### Description of Variance:

**Location:** Raspberry Island/Wabasha Street

**Noise Source:** Shakey Bones has requested a sound level variance, at a requested sound level limit of 90 dBA at 100 feet, to provide the use of a sound system for a DJ and amplified music at Raspberry Island/Wabasha Street for Shakey Bones Customer Appreciation event. The variance is requested for the hours of 11:00 a.m. to 4:00 p.m. on Saturday, July 8, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 11:00 a.m. to 4:00 p.m. for Shakey Bones Customer Appreciation event on Saturday, July 8, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 100 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 4:00 p.m. on the date of the event.
