### **Description of Variance**

**Location:** Bad Weather Brewing Company, 414 7<sup>th</sup> Street West

**Noise Source:** Bad Weather Brewing Company has applied for a sound level variance, at a requested sound level limit of 85 dBA at no specified distance from any stage or sound source, in order to present amplified music. The requested Event is to be located at the Bad Weather Brewing Company Parking Lot, 414 7<sup>th</sup> Street West for the Anniversary Party on Friday, April 21, 2017, 5:00 p.m. to 9:00 p.m., with a pre-event sound check at 4:00 p.m.; Saturday, April 22, 2017 from 12:00 p.m. until 9:00 p.m., and Sunday, April 23, 2017 from 12:00 p.m. (Noon) to 5:00 p.m., with a pre-event sound check at 11:00 a.m. on Saturday and Sunday. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will be for the Anniversary Party Event on April 21, 2017 from 5:00 p.m. until 9:00 p.m., with a pre-event sound check at 4:00 p.m.; Saturday April 22, 2017 from 12:00 p.m. until 9:00 p.m. and on Sunday, April 23, 2017 from 12:00 p.m. (Noon) until 5:00 p.m., with a pre-event sound check at 11:00 a.m. on Saturday and Sunday. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA as measured 50 feet from any stage or sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 9:00 p.m. on Friday, April 21, 2017 and Saturday, April 22, 2017 and no later than 5:00 p.m. on Sunday, April 23, 2017, the Event dates.
