Dear SPRWS Customer.

Per our phone conversation I have updated your bills estimating for the stopped meter dating back to readings taken between 7/6/2016 and 7/3/2019. I used the average of the first two bills when this account went into your name. At that time the meter was functioning correctly with consumptions of 34 and 50 units. We used .462 units per day (42 units in 91 days to estimate). This is lower than using the nation average of 9 units per person per quarter or the actual usage on the new meter.
