HUD Formula Grants Received by the City

All HUD entitlement funds are received and allocated by the City

- **Community Development Block Grant (CDBG)** - Housing, public facilities and services, economic development, planning
- **HOME Investment Partnerships (HOME)** - Expanding the supply of affordable housing for low- and very low-income persons
- **Emergency Solutions Grant (ESG)** - Preventing homelessness and assisting those already homeless





Consolidated Plan (Con Plan) Overview

- HUD requires the City to adopt a five-year consolidated plan detailing goals and objectives expected for use of HUD funds.
- Annual Action Plans (AAP) are required for years 2-5 of the Con Plan cycle to summarize the actions, activities, and resources that will be used each year to address the identified needs and goals. The Consolidated Annual Performance and Evaluation Report (CAPER) documents the accomplishments and progress toward Consolidated Plan goals on an annual basis. HUD must review and approve all plans and reporting.
- Con Plan development is a one-year process administered by PED's Planning Division that follows strict HUD guidelines and engagement requirements. AAP updates follow a three-month abbreviated process engaging the same stakeholders.
- Reflects housing priorities and policies of Comprehensive Plan.
- Addresses issues expressed by housing partners such as the Public Housing Authority, Ramsey County, and others.
- Describes the housing market conditions and community needs for affordable housing, supportive services, economic and community development, and public facilities and services based on data collection and analysis, agency and organization consultation, and community engagement.



Con Plan Needs and Goals

- Plan sets five-year priority **needs** and **goals** and the amount of funding that will go toward each goal on a five-year basis. It also describes strategies for addressing these needs.
- Includes the 2025-2026 Annual Action Plan that documents those **goals** on an annual basis, the annual amount of funding that will go toward each goal, and the specific **projects** that are planned to be funded during the program year to support the annual goals. Capital projects were recommended by the Capital Improvement Budget (CIB) Committee.

Required Agency/Organization Consultation

Discussion at organizations' meetings, in person and phone interviews:

- Public and private agencies that provide assisted housing, health services, and social services (including those focusing on services to children, elderly persons, persons with disabilities, persons with HIV/AIDS and their families, homeless persons)
- Community-based and regionally-based organizations that represent protected class members
- Organizations that enforce fair housing laws
- Broadband internet service providers, organizations engaged in narrowing the digital divide
- Agencies whose primary responsibilities include the management of flood prone areas and public land or water resources
- Emergency management agencies



Community Engagement Goals

- Inform and educate the community about the Consolidated Plan, eligible uses of CDBG, HOME, and ESG funds, and opportunities to provide feedback, and encourage participation in the development of the plan
- Solicit community input regarding housing, economic development, infrastructure, and public service needs
- Publish the draft plan for public review for a 30-day comment period and hold at least two public hearings prior to plan adoption:
 - Capital Improvement Budget (CIB) Committee during 2025 budget process (August 2024)
 - City Council during adoption process (anticipated March/April 2025)

What Have HUD Funds Been Used For?


The funds received by the City have been used to address needs identified during the Consolidated Plan Process. The needs in the last plan are categorized into nine goals, below. Goals for the upcoming plan are under development.



COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

- 2. DEVELOPMENT OF NEW HOUSING**
 - Assist in the financing of new rental housing units and homeowner housing
 - Rehabilitation of vacant structures (acquisition/rehab) or construction of new units - may include acquisition, demolition, and relocation
- 3. HOUSING REHABILITATION**
 - Carried out by the City and its Community Development Corporation partners
 - Rehabilitation of affordable rental housing
 - Rehabilitation of affordable homeowner housing
- 4. PUBLIC IMPROVEMENTS**
 - Renovation of existing public facility servicing low/moderate income neighborhoods (51% at/below 80% AMI)
 - Ex: Upgrades to a park or stormwater mitigation work
- 5. PUBLIC SERVICES**
 - Activities include fair housing activities, community engagement, domestic violence prevention, criminal restorative justice, health care, employment training, conflict resolution, emergency shelter
- 6. COMMUNITY ENGAGEMENT**
 - Funding for District Councils in Planning Districts 1-8, 11, and 17 (low/moderate income areas of the City)
 - Activities include crime prevention, community outreach and development, and policy development

EMERGENCY SOLUTIONS GRANT (ESG)

- 1. HOMELESS PREVENTION**
 - Assist individuals and families experiencing homelessness or at-risk of homelessness
 - Providing tenant-based rental assistance/apid rehousing
 - Providing overnight shelter
 - homeless prevention
 - street outreach

HOME INVESTMENT PARTNERSHIPS (HOME)

- 2. DEVELOPMENT OF NEW HOUSING**
 - Assist in the financing of new rental housing units and homeowner housing

- 7. YOUTH EMPLOYMENT**
 - Provides economically disadvantaged youth with educational and employment opportunities through remedial education, classroom and occupational skills training, and part-time employment

- 8. ECONOMIC DEVELOPMENT**
 - Carried out by the City or its Community Development Partners
 - Facade treatment/business building rehabilitation
 - Create/retain jobs
 - Provide business assistance
 - Public facility or infrastructure activities other than low/moderate income housing

- 9. REMEDIATION OF SUBSTANDARD PROPERTIES**
 - Demolishing nuisance or slum/bigly properties
