Staff Comments

PO is contesting the two remaining NSF fees for the Q1 payments that are on her Q2 bill. She was told by a representative from Highland Sanitation (HS) on March 13 the four NSF fees (\$30 each) were added to her Quarter 1 bill. The Quarter 1 invoice HS provided shows the four NSF fees were applied on Feb 22 but they were not sent to the city for assessment.

The HS representative stated in an email with the PO on March 13, "all unpaid balances are turned over to the City of St. Paul. We are unable to carry over balances from one billing quarter to the next."

However on June 4 a different HS representative stated the reason why her Quarter 2 bill was so high is because "Her normal 3 month invoice is \$112.57 the difference is the four NSF fees at \$30 each for a total of \$120.00 added to the \$112.57. The NSF fees were not turned into the city for collection on the Q1 invoice as they weren't billed on an invoice yet to this resident."

Hi Lucy,

It's Jillian again. I have everything I need to request your Quarter 1 (January - March) 2024 assessment to be reduced at the legislative hearing on your behalf. You do not need to hand deliver or email anything else to us at this time. If I need anything, I will let you know.

I understand our system automatically sent you a legislative hearing document this week. You can attend if you wish (in person or over the phone), but it is not required. I will be requesting your assessment to be lowered from \$293.27 to \$129.46 for Quarter 1 (January- March) 2024.

The reason I am requesting the assessment to be lowered to \$129.46 is because that is your regular bill without any additional charges added to it.

Also, I know we talked about it before, but there will be another assessment coming for Quarter 2 (April - June) 2024, but that will take a few weeks to be processed and sent out to you. Assuming Highland is able to process the June 13th 2024 payment without any errors, the remaining balance of around \$120 should be removed through a legislative hearing in September.

Hi Lucy

As I stated in the brief VM I left, I was able to get two of the four NSF charges removed from your Quarter 2 (April - June) assessment without going to a Legislative Hearing. There is a high probability the other two NSF charges will not be removed at the hearing because they are for checks written in Quarter 1 (January - March). Per the contract we have with Highland Sanitation, they are allowed to bill NSF charges from the prior quarter. They are not allowed to bill NSF charges prior to Quarter 1 2024 onto your Quarter 2 2024 bill.

It is up to you if you still want to move forward with the legislative hearing for the two remaining charges.

Because I had two charges removed, you now do not owe an assessment for Quarter 2 2024. The only garbage assessment on your property is the \$129.46 for Quarter 1 2024, which was previously \$293.27.

Thanks for making the two old payments go away.

I'm going to review my bank records and see what the situation was regarding, the Quarter 1 (January - March) payment(s). Given that I'm still somewhat confused, I'm not sure what the "prior quarter" is, in this sentence from your email "Per the contract we have with Highland Sanitation, they are allowed to bill NSF charges from the prior quarter." If Highland is asserting NSF, do they mean that my payment bounced, or that it was lost in the mail? Stating the obvious, those two possibilities are not the same. If, according to my records, I owe Highland money, I'd like to pay that via City Assessments.

If Highland is saying that my payment(s) bounced, I would like an opportunity to present my records at a hearing. I have a JD from William Mitchell, and worked for the St. Paul City Attorney's Office while in law school, representing the PHA at administrative hearings.

I made a payment against the \$129.46 assessment, and plan to pay it off this month.

Hi Lucy

Sorry for the confusing email. When I talked about prior quarters, what I meant to say was Highland states you wrote two bad checks in Quarter 1 2024, and they reversed the charges on February 22, 2024 (Quarter 1). They added two NSF charges to your Quarter 2 bill. Because the check was written in Quarter 1, the NSF fees are allowed to be added to the Quarter 2 bill.

Highland also states the check you wrote in Quarter 4 2023 and the check you wrote in Quarter 3 2023 were also not good. They reversed the payments February 22, 2024 (Quarter 1) and added NSF charges to your account in Quarter 2. They cannot add NSF charges from Quarter 3 2023 and Quarter 4 2023 onto you Quarter 2 2024 bill.

If you do want to attend the hearing. I can schedule it for you once the calendar opens in a few weeks. Highland is stating your checks have either bounced or come back as Account Not Found.

I hope this helped clarify things.
