I am following up on our phone conversation.

Below are the recommendations for 31 Winter:

1. (File No. J2008B, Assessment No. 208107): approve the assessment (\$192)
2. (File No. J2014A2, Assessment No. 208546): delete the assessment (\$322)
3. (File No. J2017A, Assessment No. 208529): approve the assessment (\$322)
