### NOTICE OF INTENT TO DENY LICENSE

Dear Ms. Rousseau:

The Department of Safety and Inspections (DSI) has recommended denial of the Massage Practitioner license application submitted by Deana M. Rousseau for the premises located at 2065 Randolph Avenue in Saint Paul. The basis for the recommendation is as follows:

**According to Department of Safety and Inspections, the application you submitted for a Massage Practitioner license has been pending since August 29, 2011. Your license application is pending due to the fact that you have not submitted the following information: 1) a current certificate of General liability insurance showing the City of Saint Paul as additional insured and 2) a notarized copy of a current national certification in Therapeutic Massage and Bodywork or successful completion of written and practical examinations from the City of Saint Paul authorized examiner.**

At this time you have three options on how to proceed:

1. You can submit the requested information. If this is your choice, please send it to the Department of Safety and Inspections (DSI) at 375 Jackson Street, Suite 220, St. Paul, Minnesota 55101-1806 no later than **Monday, July 23, 2012**. Information should be directed to the attention of Christine Rozek. Submission of the requested information will be considered to be a waiver of the hearing to which you are entitled.
2. If you wish admit the facts but contest the denial, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. We will need to receive your letter by **Monday, July 23, 2012**. The matter will then be scheduled before the City Council for a public hearing to determine whether to deny your license. You will have an opportunity to appear before the Council and make a statement on your own behalf.

3. You may withdraw your license application. Send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Suite 220, St. Paul, Minnesota 55101-1806, no later than **Monday, July 23, 2012**. Information should be directed to the attention of Christine Rozek. Any request for a refund of the license application fee must also be made in writing to the Department of Safety and Inspections.

**If you have not contacted me by Monday, July 23, 2012, I will assume that you do not contest the denial of your license. In that case, the matter will be placed on the Council's Consent Agenda for approval of the denial.**
