Good Morning All,

Sharon can file an appeal on the Vacant Building Registration. I have attached an appeal form. Vacant Building Registration appeals are conducted every Tuesday between 1 and 2. I have also attached the Vacant Building Registration Notice for her property, which is what would be appealed. This type of hearing is generally held over the phone, and occasionally in person if that's the appellant's preference. They are scheduled within 1-2 weeks of the appeal being filed. To the extent possible, it is likely in Sharon's interest to have someone on the line with her representing her interests.

At this type of hearing, we generally discuss whether the property should be in the Registered Vacant Building program, how to get the property out of the program and the fees associated with the program. The **Condemnation/Order to Vacate** documents the conditions and as such, it may be discussed. However, it is **not appealable as the 10-day window on the September 9 order has closed**. I have attached the Condemnation/Order to Vacate for reference, as well as the photos. Providing these to the appellant is our standard practice.

I will waive the \$25 appeal fee.

I will share this information with the team who process incoming appeals.

Hello,

I have been in communication with Margaret Berger from Adult Protection with regards to the well being of Sharon Anderson. She is currently at United Hospital and there has not yet been a plan for where she will go next. There is no family or friend that is able to help- that has been ruled out.

Sharon Anderson voiced her desire to 'appeal' the actions of DSI with her home. She disagrees with all the concerns. I can go to United on Monday (Oct 1) and help Ms. Anderson in filing this appeal. She is wanting to have a voice (no surprise).

Before I assist with the paperwork on Monday- I know the timeline is past the 10 days. I have a copy of the Correction Orders dated 8/28/24. I have not assisted a resident file a 'late appeal'. Could either of you advise and the appeal process?

It seems she is medically stable. It is very difficult for her to care for her own needs due to her disability. It appears she is confused about next steps for this process with her house.
