





6. Briefly describe the noise source and equipment involved: Concrete Saw; Hydraulic Breakers; Track Mounted Excavators; Rubber Tired End Loaders; Tractor/Trailer trucks; Dump Trucks; Air Compressors; all equipment with back up alarms per OSHA regulations
7. Address or legal description of noise source: TH52 Lafayette Bridge from Prince Street to 7th Street
8. Noise source time of operation: 24 hours per day

Briefly describe the steps that will be taken to minimize the noise levels: In lieu of breaking all existing concrete with hydraulic breaking equipment, we plan to saw cut the existing bridge deck into 8'x8' slabs and lift off the bridge beams. This will limit the noise from hydraulic breaking, although there could be minimal short duration breaking as required.
10. Briefly state reason for seeking variance: Project Schedule; Our contract requires our work in the CCLRT Operations and Maintenance Facility area near Prince Street and 4th Street to be done by July 26, 2013. Removal operations will be controlling.
