**Re: Sound Variance Request** for Friday, March 29, Program 8:30 AM – 4:00 PM (8:00 AM) sound check, Special Event Permit area Charles Avenue from Pillsbury to Vandalia.

Good afternoon. I wish to extend my apology for not being in attendance for the initial meeting regarding Pro-Life Action Ministries' request for a sound variance, I was seriously ill.

Even though Council President Jalali stated that sound variances are usually granted, regardless of the content of the program or speech, she stated a concern about access to Planned Parenthood and as a result she submitted a motion to have our request to be "laid over" until March 13, at 3:30 PM.

Some brief background: Pro-Life Action Ministries has held 12 Solemn Good Friday Prayer Vigils at Planned Parenthood since 2012. Coordinating closely with St. Paul Police, we have addressed any and all concerns presented. Charles Street is closed off from 7:30 am to 5:30 pm (times reflecting set-up with sound check and tear-down), with no disruption to Planned Parenthood. For nine of those years, the street has been shared half and half with Planned Parenthood which conducted a street party simultaneous to our prayer vigil. This is the same location as Planned Parenthood's own rally in May 2022.

We have an exemplary record of cooperation with Saint Paul Police Special Operations unit under several commanders throughout these years.

Planned Parenthood/pro-choice attendees, staged their event on the western portion of Charles Ave. closer to the residential area a half a block away, have had higher sound levels and live music that at times have competed with the ability for our attendees to hear our program in addition to the high volume of commercial truck traffic on Vandailia Ave.

I'll address some sound amplification concerns here:

- Size and power of our sound system: We use a Yamaha Stagepass 500 powered by a gel-battery, we do not use emission producing gas powered generators. - see picture attached. This is not a large system. The width of the speakers side-by-side = 27" and speaker depth is 10". See pictures attached.
- Another concern was that our speakers were aimed at the concrete wall across the street to disrupt workers and clients within Planned Parenthood (671 Vandalia). We have never intentionally pointed the speakers to echo or reverberate off concrete walls to disrupt any activity within Planned Parenthood's building. We aim the speakers down the street so our attendees can join in singing hymns. If an adjustment of projected sound is preferable, the speakers pivot 360 degrees to accommodate any concerns.
- Our event is not a protest. The only sign we have within our permit area is a full size cross.

Thank you for the opportunity to address your concerns. It is our hope that the Council for the stated reasons would grant our request for a sound variance. If the Council has any more questions and concerns, we'd be happy to address them.
