Background

Two Rental Rehab Program loans were approved and closed before the final 2025 budget was adopted. Funds were not reserved during the budget process to pay for the work obligated under these loans. Staff are requesting and recommending a budget amendment totaling \$111,092 to pay

for the outstanding loan expenses.

**Financing Structure** 

Rental Rehab Program loans are repaid to the HRA on a quarterly basis over 10 years. For the duration of the loan term, the projects will have at least 50% of their units restricted at 50% AMI or below for both income and rents.
