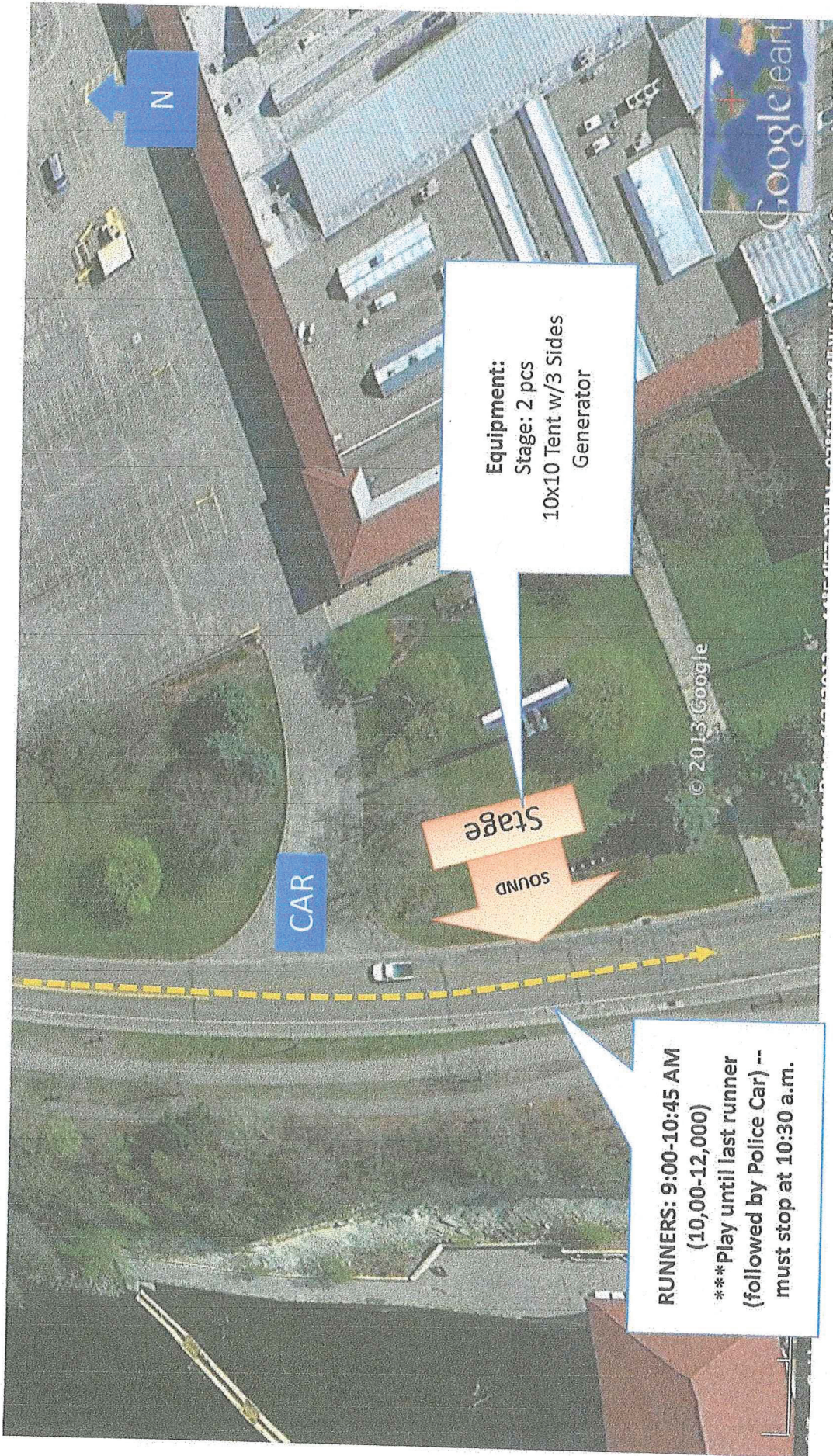
City of Saint Paul Noise Ordinance (Chapter 293)
