*Council President Brendmoen welcomed guests in the chambers and explained the requirement to set a levy limit, and the process that had taken place to approve the Library Board item.*

*Susan Earle, Office of Financial Services, gave a staff report on the proposed maximum levy, which included the 4.85% increase proposed by the mayor and an additional 17.38% to fund organized trash collection if the trash collection ordinance was repealed in November. The total maximum levy increase was 22.23% or a total amount of \$190,745,461.*

*Council President Brendmoen asked for a clarification of the difference between the levy amount and property taxes. Ms. Earle said the levy was the total the City was going to collect to fund the City and library debt, and on behalf of the Port Authority. She said the increase didn't translate to what an individual property owner would see. She said that was dependent on their own property and changes in the value of other properties in the city, as well as the amounts levied by other jurisdictions.*

*Councilmember Prince said she would be voting against the levy. She spoke in opposition to some of the items in the mayor's proposed budget and to the organized trash system. She said the contingency portion of the levy was perceived by some constituents as a threat. Council President Brendmoen clarified that the Council was voting on the levy limit and not the budget. She asked if Councilmember Prince had an alternative proposal. Councilmember Prince said she did not.*

*Councilmember Noecker said she appreciated Councilmember Prince's sentiments and was open to discussing alternative proposals. She said her hope was to be able to bring it down dramatically by the time they set the levy in December, but given the uncertainty with regard to the organized trash collection ordinance she believed the increase was the responsible thing to do to protect the City and make sure they City could meet its obligations to the residents.*

*Councilmember Busuri said he would also not be supporting this or any budget increase, and felt the City should apply budgeting principles such as not spending more than it had, separating wants from needs, and prioritizing immediate needs over those that could be postponed. He spoke about the impact of the previous year's double-digit increase on seniors on fixed incomes, and the impacts of the organized trash. He said the mayor and members of the Council were threatening to punish citizens by raising taxes if citizens voted "no" on organized trash collection. Council President Brendmoen clarified again that they were setting the levy limit and not the budget; she confirmed with Councilmember Busuri that he was proposing a zero levy increase.*

*Councilmember Jalali Nelson said she felt the vote being taken reflected the unprecedented parameters facing the Council. She said she objected to characterizing the contingency portion of the levy as a threat, and she took seriously the potential unfolding unknowns and the obligation to be ready in case the unexpected turn of events happened. She said she would vote in support of the 4.85% and continue to work with the Council on establishing priorities within those parameters.*

*Councilmember Thao said he was not entirely happy or satisfied with the proposed budget, but felt the position being taken today for setting the maximum levy was the*

*best that could be taken in case the referendum didn't pass. He said Ward 1 was hit especially hard by tax increases, but today's vote was the most responsible thing to do at this moment. He said he would vote in support.*

*Councilmember Tolbert spoke in support. He said based on state law, they had to set the maximum levy while there were still unknowns involving the final budget and the placeholder or contingency. He said it would be reckless not to have a contingency plan and be prepared for those "what ifs?". He said nobody wanted the final levy to be this high, but they have a responsibility to keep the contingency plan.*

*Council President Brendmoen said they all agreed it was an unenviable situation having to set the levy this high, but the limit needed to be set this early to allow the County to send out estimated tax statements. She said 4.85% was low and had required giving up some wants and making priorities such as some public safety investments and resources for enforcing the minimum wage. She said there was as lot they still needed to work through. She said the contingency protected city services and protected the bond rating, and by the time we pas the levy in they set the levy in December, the unknowns would be known. She said the Council had proven that it could and would bring the levy down, and that was her commitment.*
