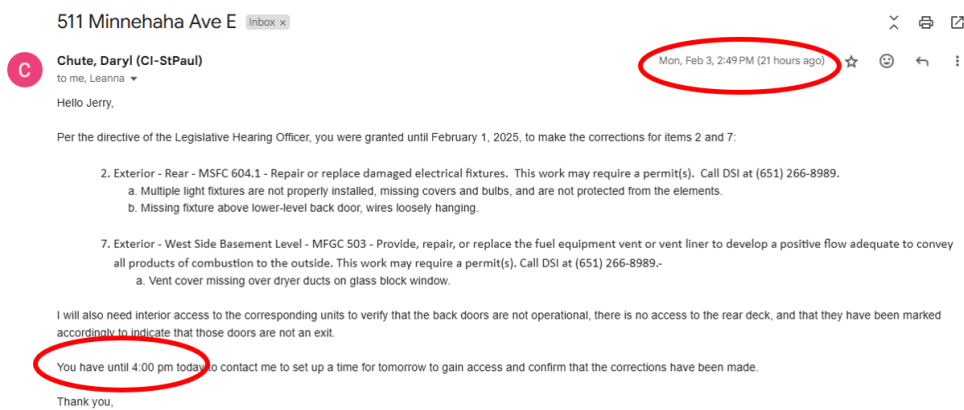
To whom it may concern,

I am writing you regarding my property located at 511 Minnehaha Ave. E. Can anyone let me know who I can speak with about getting a copy of all correspondence that has transpired in the last 2 years regarding my property? Or, if there is a website I can view all correspondence?

Per the legislative hearing officer (Ms. Mormond (sp?)??) and her associates; [towards the end of Jan 2025] I am required to make certain corrections. At that meeting I was told what was being advised and what decisions have been made. I have not yet received anything in writing about these decisions. Nor, when the next hearing may be to bring up any concerns. Hence, I am asking where I can go to print off all correspondence thus far. Also, Where I can find these decisions that have been made. Or, what options I may have if I choose not to accept the findings of the legislative hearing officer. I believe we came to terms but without anything in writing I am uncertain.

In the recent past the legislative hearing officer stated I would have to hire an independent structural engineer regarding what the fire inspector has found, if I disputed the findings. I hired the independent structural engineer who agreed that the building was indeed structurally sound in all but one of the areas the inspector had thought were lacking. However, despite what the structural engineer found, I have been asked to work on areas that were not found to be lacking by the independent structural engineer.

Finally, I recently received an email from a city fire inspector. (Mr. Daryl Chute). The email stated that I had one hour and 10 minutes to respond to a request that he enter to view postings the next day. Unfortunately, I did not get this email till today. How do I proceed? I have included Mr. Chute in this email.
