Rachel Tierney, Assistant City Attorney for the Department of Safety and Inspections (DSI), distributed a summary and report from an October 8, 2010 inspection of the restaurant. She said based on the inspection report and a subsequent conversation with the restaurant owner and his attorney, DSI did not have a new recommendation.

Jay Benanav, attorney representing the restaurant owner, was allowed to address the Council. He said the restaurant owner had offered to voluntarily surrender their licenses effective immediately. Councilmember Stark confirmed that Mr. Benanov was asking that the Council not revoke the licenses.

Ms. Tierney said she wasn't sure of the distinction between a revocation and voluntary surrender, but she recommended that the Council act on what was before them.

Councilmember Bostrom recommended that the Council pass the resolution before them and review the item the following week if necessary.

Councilmember Stark moved approval.
