Dear City of Saint Paul Council Members,

This letter is in regards to shootings over the past months, and years at El Alamo Cantina. I am primary owner of El Burrito Mercado, our family owned business has been here since 1979, it is now operated by myself, my sister, and my niece.

We are writing to express our immense concern for the continued acts of violence and human endangerment at or near Alamo. Our family are huge supporters of entrepreneurs and small business of all types, we wish to them all succeed. However, we also that believe that with being an owner, especially in a residential community, comes a deep responsibility for the well being of the customers and for our community as a whole. We try and practice what we preach, and we hope our neighboring business' do the same, and this is why I write this letter, when there are several incidents of shootings at a business, something is definitely not being addressed, and that is a choice.

All choices have consequences, as a business owner, you and only you have the exclusive right to establish the kind of climate you create in your own business- it's your own business, your vision, your marketing, your brand, and we can blame nobody for it being anything we don't want it to be. We can't control the people that come in to our business, we can't control how people behave, however, we can respond by controlling the environment and having a zero tolerance for certain unwanted behaviors. There is simply no excuse for multiple shootings at a business in our neighborhood! After the last shooting extreme measures could have been taken to change the environment in and around the bar. There are so many ways to achieve this, to name a few examples: hire a business consultant, change your image, work with WSCO, NEDA, St Paul Police, come to meetings and get involved in the community.

This is our community, this is our customers, these are our family and friends in this neighborhood, and it concerns and affects us all!

This may not be the best example but it's what comes to mind. Our business got fined recently because of a broken cooler that we thought had been repaired because it was working days prior to the inspection, but when the inspector came, the temp was off again. In spite of demonstrating paid invoices, we will be fined. And for this a fine seems an appropriate

consequence. We get it and food safety is important to us, we are diligent on these issues, if food doesn't hold certain temps after a period of time it's a risk that food goes bad and a person can get sick, it's part of the risk in our industry. As additional result of this, we threw away 100lb of food AND will pay a fine and already lost on the paid invoices for the cooler. It kinda boggles my mind, that a business that has continuous shootings where human lives are at risk of violence and death? My point of sharing this is to implore that you please make sure the consequence be fitting. Every business has varying level of risks, but one can only remain in business by minimizing risks and implementing safe and secure practices.

I trust that you all have the best interest of human lives in mind, and thus your decision will be one that reflects accountability for business to operate in a way that our community and visitors feel safe. We have nothing personal against the owner of Alamo, we don't know him/her, however we do expect a fair and serious consequence as a result from the most recent and repeat shooting at this neighborhood business.

I work at the Alamo and also am a customer of the Alamo before I worked there. I am just as frustrated and upset as anyone with some of the recent issues that have happened by the Alamo along with other incidents that are happening all over the West Side. I in no way condone it in my neighborhood. In saying that I will also say it is upsetting and frustrating that a few incidents or people can make outside people judge the bar or customers of the bar. I can tell you one thing for sure if you think closing the Alamo will solve the problems on the West Side they won't!!! It will just move up the street or down the street or over a street. The Alamo is a GREAT bar with all kinds of customers from different walks of life. We have lawyers, teachers, city workers, community leaders, janitors, servers, parents, and anyone else you can think of as customers just like any other bar does. I have been to ALL THE meetings before yesterdays with the city and community and the Alamo and listen to people that work at WSCO AND THE POLICE DEPT. ETC talk about how they all wanted to come together and come up with a solution. Guess what? It was all talk and none of them never followed through. We never were contacted from WSCO or the police with proactive ways to help not only the bar but the community in general. I hope you do not decide to close the bar down. I think that is pretty extreme based on the types of violations it

is being violated for. I'm not saying they are right but cmon is it enough to close it down? The WHOLE CITY has issues. I don't think I need to name other places but I'm sure your aware!

The Alamo doesn't get near the credit it deserves for all the positive things it has done or continues to do!!! The Alamo holds countless fundraisers for the West Side Booster youth teams for uniforms and for them to have a season. Countless benefits to help people raise money for funerals and/or medical bills... It holds drives to collect school supplies for the youth as well as coat drives. I am writing this letter to hopefully give you some personal insight into my experiences at the Alamo Bar, I have been employed ther for 10 years. I am 58 years old. I spend 5 to 6 nights a week there working. I came to the westside from a white middle class neighborhood where I raised my family. I had no idea about any other life styles or walks of life. I have made the westside my home. I have learned many other ways of living and cultures that I had no idea existed in my sheltered world. I have met so many people in the last 10 years who have forever changed my life.

While there have been a few negative things that have affected the Alamo many more positives have been gained. I have worked with DSI, WESTCO , St Paul PD and yourself to fix problems no one has helped to date. I certainly do not want bad things going on and have put all my energies into correcting them. To close the Alamo does not fix any of the problems the westside has been experiencing. The same people still live in the neighborhood and will continue to do so. Mo arrests have ever been made on the few incidents we have had even though video and names have been provided to the SPPD. The housing on Robert and Cesear Chavez Street has had two shootings in the last 3 months. Do we close the housing project down. Of course not.

The westside is a very unique neighborhood of which I am glad to have been a part of and hope to continue to do so. We have operated approximately 3600 days with a few negative incidents. Pick up a paper because this is going on in every neighborhood throughout the City of St Paul.

In closing I am asking that you reconsider closing the Alamo down and working with us to identify problems. We cannot do it on our own. These people are my family and I care about each and everyone of them.
