Hi Robert,

We weren't given your contact info when we called. We were sent to Matt Dornfeld, Clint Zane and Nathan Bruhn. We have text messages between my partner and the inspectors showing that we reached out.

Assessments told us we missed the 'appeal' period which doesn't seem right when we were told to 'ignore the letter' every time we inquired about it. The DSI office told us it was a mistake which was nerve wracking given the large amount of \$5K+, but there's nothing further we could have done after being told repeatedly that it would be taken off. My partner even went down there in person to the DSI office to inquire about this letter and was told the same thing.

The assessments office told us that it can be removed if it's brought to the City Council. She said she's seen assessments be removed many times after it's 'certified'. See below from their office:

*If the item has been certified they have missed their appeal period. DSI can complete the required resolutions to have City Council remove it.*

Please let us know who typically starts this process and if we can meet in person at the office in downtown St. Paul to discuss. My partner can be available anytime next week to meet.

The home on the property was demolished but a storage building remains. Notes in system say that building and electrical permits are required for compliance and occupancy. No permits have been pulled to clear the storage building. The owner just had VB fee's assessed, which from my standpoint seems correct.
