Thank you for supporting changing the city charter to allow for administrative citations. The unique situation St. Paul finds itself in right now is truly bizarre. Every major city in the country has the ability to administer administrative citations for violations of their ordinances. Among the 25 largest municipalities in Minnesota, St. Paul is the only one to not have access to administrative citations. It's a basic function of government, but for some reason, St. Paul doesn't have it.

We have good ordinances that were passed to protect us like the \$15 minimum wage, wage theft protection, renter's rights protection, earned sick and safe time, and so on, but currently the city lacks the ability to enforce these ordinances unless things escalate to court action.

Now anyone who's had to deal with the courts or who's read up on them know that they are completely overwhelmed and lack the resources and capacity to deal with the volume of cases that come before them. It's completely unrealistic to expect the courts to handle what should be a basic function of the city government.

It's also completely unrealistic to expect the poorest and most vulnerable of us, who are most likely to be victimized by slumlords and shady employers, to have the time and resources to navigate the courts and force their abusers to comply with the law.

Many victims have been waiting in the courts for years to resolve their issues, when they could have been protected if the city had the ability to protect them.

And if individual citizens find themselves on the wrong end of city ordinances, we don't want law enforcement to see criminal citations and prosecution to be the only tool the government has. We know how deeply that can hurt vulnerable communities. We need the alternative. We need the city to have this basic tool for the system to work. Thank you.

I am reaching out to you today because right now, St. Paul doesn't have an equitable way to ensure that our ordinances are followed.

When St. Paulites come together to pass important ordinances like Earned Safe and Sick Time, Minimum Wage, and Rent Stabilization, we expect that employers and landlords will follow these policies and, if they don't, the City will ensure that they do.

This has high stakes. Almost half of the residents in Saint Paul are residents of color. The majority of renters in our city are renters of color. We also know that enforcement mechanisms that skew towards criminalizing tends to hurt communities of color the most. The legislative process which generated Ord 25-2 was fatally deficient. None of the 15 people who voted to allow the city council to amend our charter on December 12, 2024, had complied with the legal requirements necessary to serve as charter commissioners.

Two of the 7 people identified in Judge Grewing's August 19, 2024, Order never filed any Oath & Acceptance, thereby disqualifying Joe Spencer and Acooa Ellis. Jon Fure and Maisue Thao failed to file their Oaths within the 30 day deadline set by Judge Grewing's Order.

None of documents filed in 2024, had a "proper oath" as required by Minn. Stat. § 358.116, which requires the declarant to specify the county and state where he or she executed the oath.

In addition, the documents submitted by all 8 people named in Judge Castro's 2022 Order, similarly failed to specify the state and county of execution. As a consequence, all 15 votes cast at the Charter Commission's December 12, 2024 meeting were *ultra vires*, i.e., devoid of any legal authority.

I wish to thank John Purdy for pointing out the numerous procedural defects in the Charter Commission proceedings. I also agree with Mr. Purdy that the City has failed to show any compelling need for a charter amendment allowing the city council to levy civil fines.

If possible, I would like to include with these remarks 15 documents: the two appointment orders of Judges Grewing and Castro, along with the 13 documents submitted as oaths by the 15 people who cast votes on December 12, 2024.

## MEMORANDUM

The City of Saint Paul's rules for governance are found in the Home Rule Charter<sup>1</sup>. The Charter defines the roles of the City Council and Mayor along with defining the City's general authority to finance and tax for public services. A city's charter is, in effect, its local constitution. *See Woo v. Superior Court*, 83 Cal. App. 4th 967, 974 (2000) (A city charter is the city's constitution), citing, *City and County of San Francisco v. Patterson*, 202 Cal. App. 3d 95, 102 (1988); *see also Phillips v. City of Atlanta*, 77 S.E.2d 723, 727 (Ga. 1953) (charters "confer and define powers and provide for machinery to operate the government."); *Bivens v Grand Rapids*, 505 N.W.2d 239 (Mich. 1993) ("A charter is a city's constitution"). Under Minnesota Statute, and consistent with the Minn. Const. art. XII § 4, a home rule charter "may provide for the establishment and administration of all departments of a city government, and for the regulation of all local municipal functions, as fully as the legislature might have done." Minn. Stat. § 410.07.

One of the main responsibilities of a charter commission is to keep the charter current by regularly reviewing its provisions and ensuring it is consistent with state laws and the needs of the community. Over time the needs and values of the community change. Consequently, it is essential for charter commission members to be representative of the entire community, both in geography and diversity. Additionally, new commissioners bring fresh perspectives and new skills, and are more likely to question conventional practices.

The City of Saint Paul is comprised of seven Wards and each Ward is represented by a city council member elected by residents of that Ward. As such, the Saint Paul Charter Commission should be comprised of representatives from each of the Wards. Moreover, the City of Saint Paul is rich in diversity. The most recent census reflects that Saint Paul residents identify with the

following race/ethnicity: 19.1% Asian; 15.5% Black or African American; 9% Hispanic or Latino; and 6.3% Two or More Races. <https://www.census.gov/quickfacts/stpaulcityminnesota>. As such, the Saint Paul Charter Commission should include members that reflect its diverse community. Having been guided by the aforementioned principles and after careful review of the applicants and current members of the Saint Paul Charter Commissioner, this Court appointed eight Commissioners to serve for a term ending on July 31, 2026.

The Saint Paul Charter Commission has been guided by talented and dedicated public servants. The City of Saint Paul has been fortunate in this regard. This Court recognizes and applauds their accomplishments, and gives special recognition and thanks to Brian Alton, who has served on the Commission for 16 years, most recently as Chair of the Commission. His knowledge, leadership, and experience have significantly benefited the people of the City of Saint Paul.

Dear Members of the Saint Paul City Council,

My name is Patrick Ingram, and I am a proud resident of Ward 1, living in the Frogtown neighborhood. I am reaching out virtually to share my comments regarding today's discussion on Ord 25-2, as I am unable to attend the meeting due to a scheduling conflict.

First, I want to express my gratitude and admiration for the leadership and dedication you bring to our city. I was honored to support your respective campaigns and remain proud to live in a city guided by such a diverse and resilient group of women. Your ongoing efforts to prioritize the best interests of Saint Paul have not gone unnoticed.

In 2022, I purchased my home in Frogtown. Since then, I have witnessed a significant increase in property taxes—approximately 25% in the first year alone, with continued increases over time. However, as these taxes rise, the conditions in our neighborhood have not reflected this investment. Many homes remain in disrepair, rental properties are often maintained in unacceptable conditions by negligent landlords, and numerous properties are abandoned altogether.

Reports and complaints made to the Department of Safety and Inspections (DSI) about these violations frequently go unresolved, and the issues persist due to the root causes of the issues not being fully addressed. A review of the city's GIS tool reveals that many of these landlords have repeated violations, yet little action has been taken to enforce compliance, as reflected in past City Council meeting minutes.

For these reasons, I urge all members of the council, including my Ward 1 representative, to support the administrative citation proposal outlined in Ord 25-2. Residents and landlords who consistently violate ordinances without taking meaningful steps to rectify the issues should be held accountable. Saint Paul deserves neighborhoods where all residents can thrive in clean, safe, and compliant environments.

At the same time, I encourage the council to consider providing support for property owners who are actively working to address violations but face economic challenges. Exploring grant programs and other resources to assist those genuinely striving to improve their properties will ensure that we foster equitable and compassionate solutions.

Thank you for your time and consideration. I look forward to continuing to collaborate with you to advance the health and well-being of our community.

## **Maria Isabel Gonzales, 45 years old, Saint Paul, MN**

### **Personal Testimony**

I live in a one-bedroom apartment near Hazelwood and Maryland. We began talking with the manager before moving into this complex back in January 2024, and we were told that utilities would be included. However, when it came time to sign the lease, the apartment manager mentioned politics in the City of Saint Paul and claimed that, due to these changes, they had to start charging separately for utilities.

Originally, the rent was \$995 per month and included utilities. After this adjustment, the total for rent and utilities went up by about \$180 per month. Now, we are also facing a new increase in January 2025, where the rent will go up to \$1025.

These additional costs include:

- An electric bill that varies between \$25 and \$50 per month.
- Water and garbage fees of about \$120 per month.

Overall, my monthly housing expenses now approach \$1200. I am unsure whether it is legal for the landlord to change the terms in this way and start charging for utilities separately, given that we initially agreed they would be included in the rent.

### **Testimony 2 - Erenia Luna**

A friend has been living next to the Bymore Supermarket on Payne avenue for two years. Since she moved in, no maintenance has ever been done in her apartment. The carpet has been there since before she arrived; it's old and dirty. She and her roommate tried cleaning it, but it was impossible to get it fully clean.

At one point, strong winds tore off part of the roof. They reported it, but management only covered it with a piece of wood and never repaired it. The hallways are also very dirty and

neglected. However, they always receive a reminder the day before rent is due, yet maintenance requests are ignored. The curtains are damaged as well, so they resort to using bedsheets to block the light.

### **Testimony 3 - Jazmina Ibarra**

Jazmina lives nearby in a rented house that is also in poor condition. She has requested new appliances but has not received a response. Her kitchen is in very bad shape, and although she has asked for replacements, there has been no reply. The rent for this house is \$1,300.
