[Additional Information About Bulky Item Pickup:](#)

- All residential households (1-4-unit homes) are allowed 1 bulky item pickup per unit per month included in their garbage service.
- A bulky item is defined as 1 cubic yard worth of material. Examples include a standard stove or a couch.
- If you would like to set out more items than your monthly allotment, you may do so for the cost of \$30 per item. This charge will be automatically applied to your quarterly garbage bill.
- Oversized items *may* be charged as more than 1 item. For example, a large sectional couch with multiple pieces.
- Bulky item collection requests must be received at least 2 business days in advance, and will be scheduled for your next available garbage collection day.

**Refrigerators, Water Heaters, Grills, Small Engines:** All items must be emptied of food and liquids. For example, water heaters need to be drained of water and any food items need to be removed from refrigerators, bagged and placed into your garbage cart. Oil and gas are required to be drained from small engines and grills. Please bring used gas and oil to the Environmental Center located at 1700 Kent St in Roseville.
