Abby Finger, Property owner of 971 Beech Street, received a summary abatement order from the city for items stored outside a duplex she owns in the city of Saint Paul. See attached abatement order. She called into Aspen to have the bulky items collected from her property. It looks like Aspen only collected the two cabinets she called about. They did not collect the rest of the items stored around the cart.

Ms. Finger states that she called a second time to have them collect the rest of the items. There is no record with Aspen of this call. See attached response from Aspen. Aspen did not remove the rest of the items from the property. The compliance date came and passed during this time. Because the due date of the violation had passed the city removed the remaining items from the property and charged Ms. Finger for the work.

Ms. Finger contacted me as she does not believe she should have to pay for the abatement as she feels that she tried to schedule a pickup of the items and that the hauler failed to remove them from her property.
