

SUMMARY OF ENGINEERING RECOMMENDATION
Reconstruction at 96 Mounds Boulevard

PROJECT:

This project is to reconstruct two additional sidewalk panels in front of 96 Mounds Boulevard during the citywide sidewalk reconstruction scheduled for the east side of Mounds Boulevard between McLean Avenue and Urban Place.

EXISTING CONDITIONS:

Mainline city sidewalk needs reconstruction work to correct defective sidewalk panels.

INITIATING ACTION:

This order was initiated by Public Works in agreement with the Property Owner. Public Works agreed to perform the work with the Property Owner paying the costs. Property Owner has signed a Waiver of Notification to allow Public Works to construct two additional sidewalk panels in front of their property during the 2014 construction season.

The project to be done during the 2014 construction season.
