When I received the notice, I am the estate executor and do not receive the bill. I called the hauler and was told to pay the city for July -September 195.23 on Jan 8th. And paid the hauler 181.91 for Oct-Dec. I have included a screenshot where you will see that payment was received and we are now showing a (-96.98) balance.

Dear Amanda.

Thank you for contacting the City of Saint Paul about your Quarter 4 (October - December) 2024 garbage bill with Republic Services. This letter was not sent to you in error, and there is a payment due to the City of \$190.18

In the City of Saint Paul, garbage service is paid in advance on a quarterly basis. When bills are unpaid by the end of the billing cycle (three months), they are transferred to the City, who then pays the bill. This zeros out the account with the hauler and a pending assessment for delinquent garbage is placed on the property for the unpaid amount.

Your Quarter 4 (October - December) bill of \$190.18 was paid after the billing cycle ended. As a result, Republic Services sent your delinquent Quarter 4 (October - December) bill to the City which the City paid on your behalf (which set your payment history with Republic Services at a zero balance for Quarter 1). Therefore, you currently owe the City \$190.18.

You made a late payment of \$190.18 to Republic Services, which part of that payment paid for the Quarter 1 billing cycle, and part of the payment is a credit balance. Republic Services will issue you a refund check in a few weeks, or if you prefer, I can ask Republic Services to apply the \$96.98 credit to the assessment amount, so the amount owed to the City of Saint Paul is reduced to \$93.20.
