You do not need to have a fire certificate of Occupancy inspection if you have no intention on renting your home and are putting it up for sale.

Per the Legislative Hearing, you had 90 days from January 6<sup>th</sup>, 2015 to have the Fire Certificate of Occupancy reinstated in order to waive the Vacant Building fees.

Since you are not going to be addressing the escape window issue, and have no intention on reoccupying until after the sale, we would not reinstate the Fire Certificate of Occupancy.
