Purpose: This permit allows the vehicle to be operated with expired registration or without a license plate while the owner awaits the receipt of license plates from Driver and Vehicle Services. This permit is only valid for the vehicle identified above. Any alteration VOIDS this permit.

Attestation: By use of this permit the vehicle owner or the owner's authorized representative attests that:

- All information printed on this permit is accurate
- Vehicle is insured while operated upon the public streets and highways as required by Minnesota law. (Minnesota Statutes: 65B.48 subd. 1, 169.791 subd 2, 169.797 subd.4)
- Vehicle will be operated in compliance with the federal and state laws that apply to this permit and to this vehicle's class of registration

Instructions:

1. Fold permit in half on dotted line
2. When practical, affix permit to the inside rear window on the driver's side of the vehicle, making sure that the expiration date is clearly visible from outside the vehicle
3. Once license plates are received, display the plates as soon as possible and remove the permit from the vehicle

Acknowledgment of Data Privacy: The vehicle owner or the owner's authorized representative acknowledges that at the time of application they were informed that: (1) the information collected is used to identify the motor vehicle and the vehicle owner to whom the permit is issued; (2) they were not required to submit the information; (3) failing to submit the information would result in the Department of Public Safety being unable to issue the permit; and (4) the Department of Public Safety releases this information only as authorized or required by state and federal law.

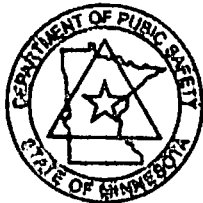
