On 6-11-15 at 1716 hours, SQD 366 Welters/Leopold, were sent to 963 Conway St #1 on a welfare check. The call stated that an elderly male who lived at this address had not been seen for about two weeks.

When we arrived on scene we attempted to make contact with anyone inside, but no one answered at both the front and back doors when we knocked. All the windows were covered either by blinds or curtains on the ground floor and we could not see inside. We spoke with multiple neighbors who all said that the occupant of the house, "Acey," had not been seen in about two weeks. They said that this was unusual because they would all see ACEY walking the neighborhood at least once a day picking up cans. In the mailbox to the lower unit of 963 Conway we found mail to ACEY DODD (DOB/4-17-47).

We spoke with STEVEN RICHARD CORNIER (DOB/8-17-57, 651-778-0571) who lived across the street and he told us that he would see DODD every single day at least once, walking around the neighborhood collecting cans. CORNIER said that DODD had a stroke years back and was not in good health overall. CORNIER said that DODD did not drive, he lived alone and did not believe he had any family in the area.

We called all the area hospitals to see if DODD had been admitted, and he had not. We also contacted the fire board to see if there were any medical calls, and checked RMS. There was no records of any calls to the address, or any records listing DODD.

We called Sqd 306 Sgt Tanghe and informed him of our call. After consulting with him he authorized us to force a door to check if DODD was inside the house in medical distress. We forced the back door to the basement which led to the main level. We checked the residence for DODD, but he was not inside. We then called a board up crew to re-secure the door. SQD 381 Smith/Titus came and took photo's of the door. After the door was secured, we cleared the scene.
