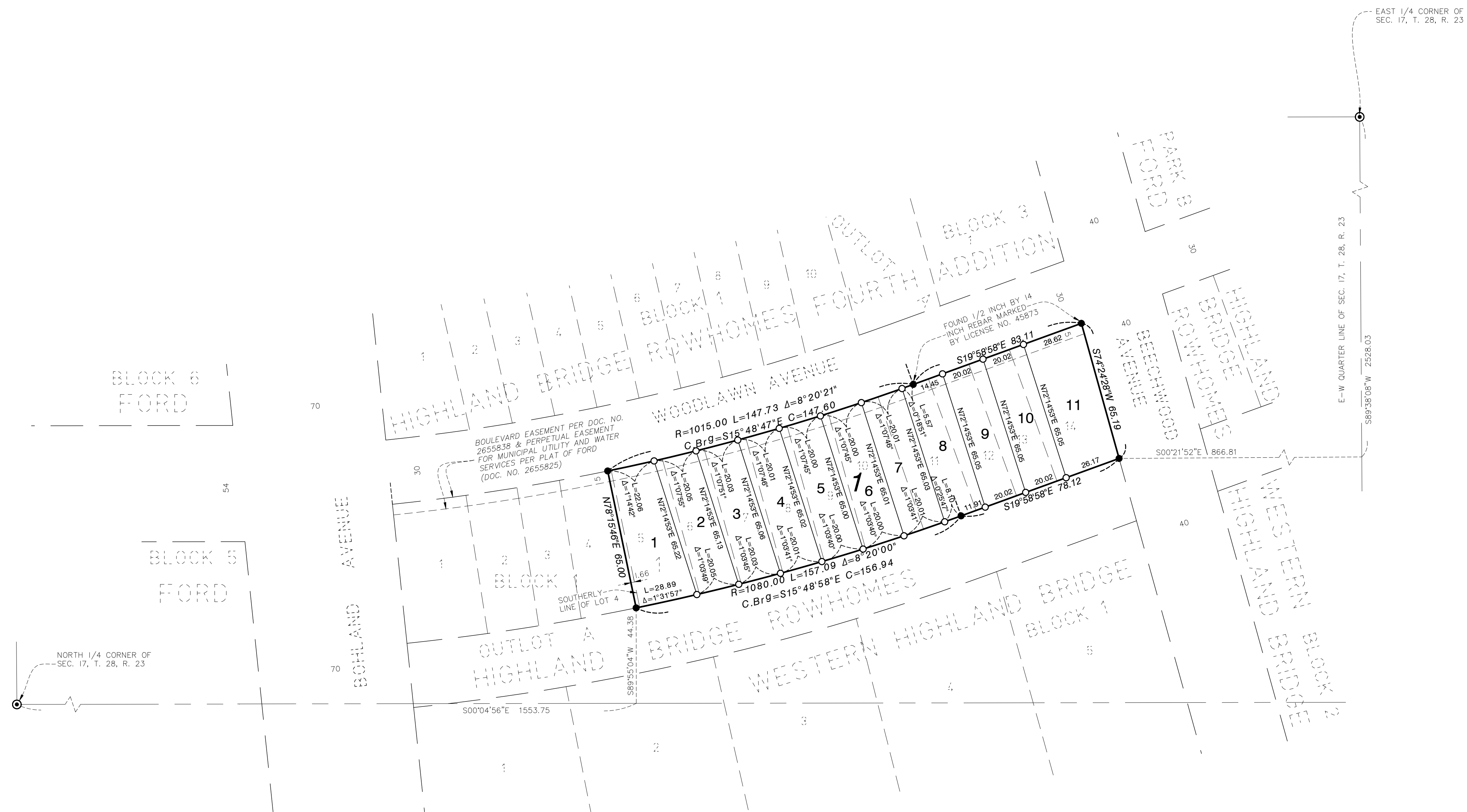
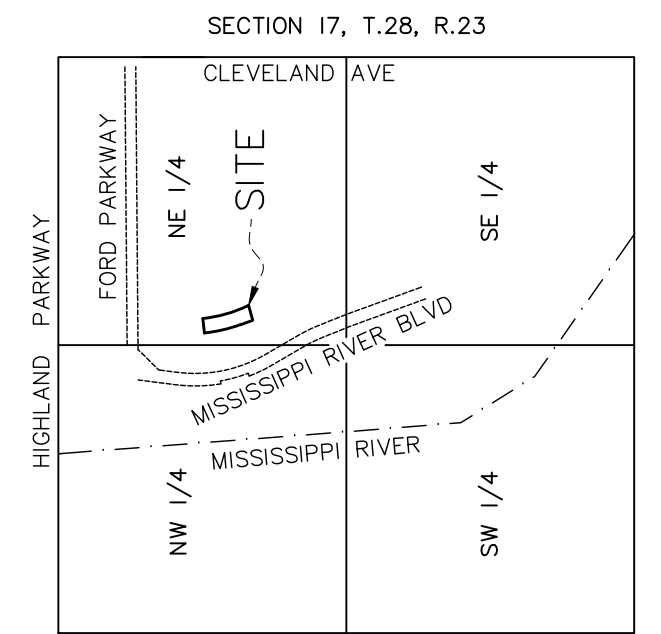


# HIGHLAND BRIDGE ROWHOMES FIFTH ADDITION PRELIMINARY PLAT

F2 RESIDENTIAL MIXED LOW

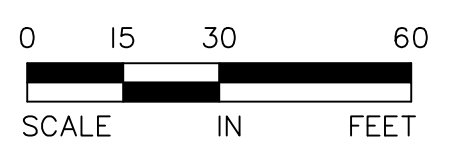

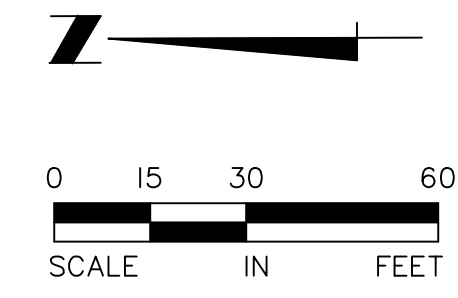

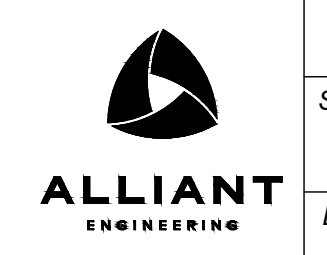
