Location: On Shepard Road between Washington Street and Sherman Street

Noise Source: Mike Cofrin, Podium Sports Marketing President, has requested a sound level variance, for 85 dBA at no specified distance, to present amplified sound with use of a sound system for the Turkey Trot Saint Paul at Shepard Road between Washington Street and Sherman Street on Thursday, November 25, 2021. The variance is requested for the hours of 7:15 a.m. to 10:00 a.m., with a pre-event sound check at 7:00 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 7:15 a.m. to 10:00 a.m. on Thursday, November 25, 2021, with a pre-event sound check at 7:00 a.m. for the Turkey Trot Saint Paul event. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from all sound sources on November 25, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 a.m. on November 25, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits

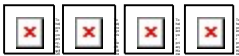
