NOTICE OF INTENT TO SUSPEND LICENSE

Adam Jariis Frank's Dairy & Deli 1201 Edgerton Street St. Paul, MN 55130

Cigarette/Tobacco license held by Frank's Dairy & Deli, Inc. d/b/a Frank's Dairy & Deli for the premises located at 1201 Edgerton Street in Saint Paul.

Dear Mr. Jariis:

The Department of Safety and Inspections (DSI) has recommended suspension of the Cigarette/Tobacco license held by Frank's Dairy & Deli, Inc. d/b/a Frank's Dairy & Deli for the premises located at 1201 Edgerton Street in Saint Paul. The basis for the recommendation is as follows:

On December 1, 2011, a tobacco compliance check was conducted at Frank's Dairy & Deli located at 1201 Edgerton Street. A seventeen year old male entered your store and asked to buy cigarettes. He was not asked to show his identification, which would have indicated he was underage. Nevertheless, the clerk sold him a package of Remington cigarettes. Sale of tobacco to an underage person is a violation of Minn. Stat. § 609.685 and Saint Paul Legislative Code § 324.07(c).

While the inspector was inside of your establishment immediately after the compliance check, she observed the clerk sell an individual cigarette to a customer from a green & white pack of Newport cigarettes. She also noticed that the clerk did not check the customer's identification before making the sale. When the inspector asked her about the sale, the clerk said she was not aware that she couldn't sell individual cigarettes. of individual cigarettes is a violation of Saint Paul Legislative Code § 324.07 (a).

Per Saint Paul Legislative Code §324.11 (b) (1), the licensing office will recommend an upward departure to a thirty (30) day suspension of your Cigarette/Tobacco license. This recommendation is due to the fact that the two violations are considered a 2nd and 3rd violation occurring during the course of the same compliance check.

At this time, you have two options on how to proceed:

- 1. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by **Monday**, **January 2**, **2012**. The matter will then be scheduled before the City Council for a public hearing to determine whether to impose the thirty (30) day suspension of your Cigarette/Tobacco license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 2. If you <u>dispute the facts</u> outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter with a statement disputing the facts and requesting an administrative hearing by **Monday**, **January 2, 2012.** At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

If you have not contacted me by Monday, January 2, 2012, I will assume that you do not contest the thirty (30) day suspension of your Cigarette/Tobacco license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
