I have no objections to the license application regarding the Super America at 1580 Ford Parkway.

Your notification has reminded me, however, of a problem that has long concerned me with the on-street parking around the station. Some Super America customers park wherever possible along the West side of Snelling Avenue from the corner of Ford Parkway and Snelling all the way South down to Hillcrest.

As a resident living on Hillcrest who parks in a garage in the alley, I often leave the alley onto Snelling with blocked visibility to both the right and the left. (Note, too, that the alley is parallel to the driveway for Super America). Trucks, including school buses, often park on the right on Snelling. Business trucks sometimes park at the curb to the left, obstructing the view of vehicles turning right from Ford Parkway to go South on Snelling.

I am asking you to consider at this time restricting all parking on Snelling on the West side of Snelling from the corner of Ford Parkway to Hillcrest Ave. I am respectfully suggesting an in-person evaluation of the traffic patterns I describe, and of the restricted visibility with the current non-restricted parking on Snelling.

Thank you for the notification for a change of ownership of SuperAmerica at 1580 Ford Parkway.

My family has lived at 1589 Hillcrest Avenue since June 2004 and have never considered Super America a good neighbor. However, we do have concerns about a change in ownership.

#1) Noise Level.....Our back yard is directly across the alley from SuperAmerica, with our family room being less than 50 feet from the flimsy wood fence that exists now. The amount of loud noise that is tolerated by the current owner is unacceptable. There are constant loud radios and loud patrons that disrupt our family life. In fact, just this morning (Sunday, November 28th at 7:30 am,) there was a patron that was blaring his radio. So loud, in fact, that I could hear it plainly from inside our house with closed windows and TV on. We have had multiple issues with this. My husband and I are responsible for working with previous store management to get signage hung regarding loud noise that is posted on the fence in the SA parking lot. In the summer months it is **miserable to be a neighbor**. We have talked to management countless times, and have called into the Saint Paul Police non emergency phone number many, many, many times. The current store employees are unwilling to ask patrons to cooperate with the noise ordinance.

For this, we are requesting

- #1) A brick fence be installed, not a wood fence, to help with noise reduction directly into our house and backyard.
- #2) A security officer present to curb noise, loitering and crime.
- #3 We demand the continuing policy of No Alcohol Sales be enforced.
- #4) We would love to see closing hours of 10:00 weeknights, 11:00 on the weekends. (What other retail business in Highland is open later than that anyway?) It sure isn't very neighborly to be open late. We hear everything from the parking lot...including employees using the garbage dumpsters, playing loud radios upon coming to and leaving work, etc.
- #5) The commitment that all employees will enforce strict noise ordinance laws. No tolerance of loud radios, loud patrons, or loitering.
- #6) We request regularly scheduled meetings with management to discuss the noise problem.

We wish there was not a retail business there at all. When we purchased our home we were completely misled by the previous owners as to how intrusive the noise really is. We have 3 children who cannot have their windows open at night in the summer because of the noise coming from the SuperAmerica parking lot. We rarely can use our deck for meals or entertaining in the summer due to the disruptive noise and loud behavior that goes unenforced by current employees. We are desperate for things not to get worse.
