As owner or person(s) responsible for : 76 WHEELOCK PKWY E you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1. Please remove improperly stored or accumulated refuse including: loose and scattered litter, scrap wood and metal, recycling materials, building materials, semi trailer, or rubble, tires, brush, etc., from the vacant property. Thank you! Comply before July 19, 2016
2. Cut and remove tall grass, weeds and rank plant growth from yard, blvd, and alley areas. Comply before July 19, 2016

If you do not correct the nuisance or file an appeal before July 19, 2016 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
