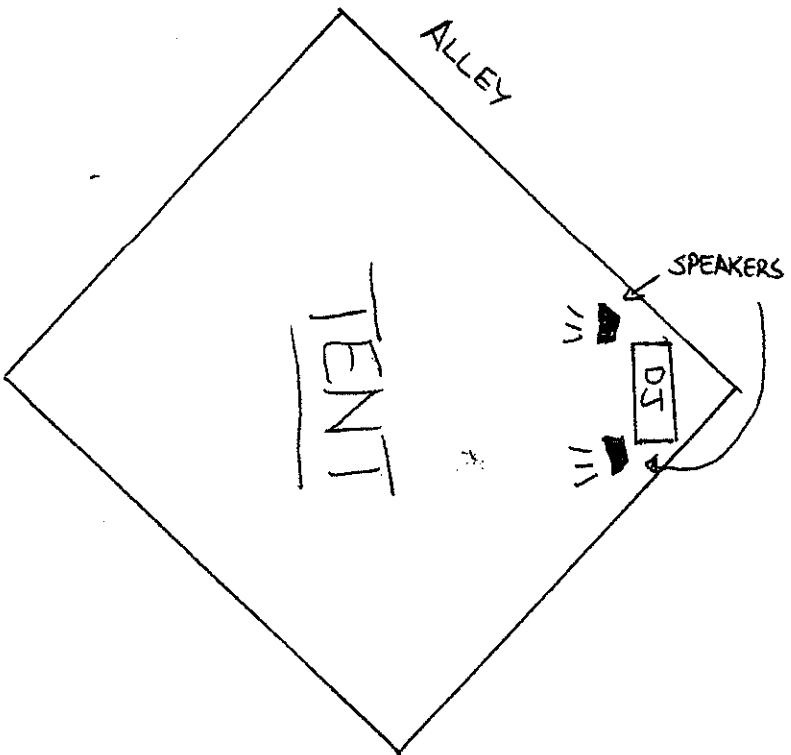

Enclosed please find our Sound Level Variance Application and a check for \$175.00.

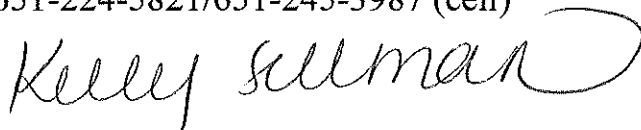
