On 03/02/2007 I, Sgt. John Riley, spoke with Randall Mann who identified himself as the property manager for the building located at 380 Randolph. Mann stated the both vehicles involved in the fire were his. He told me the vehicles were present in an attempt to deter trespassers from entering the property. Mann explained the property has been plagued with problems caused by trespassers who vandalize the building and property within it. He stated the problems have been occurring for several years and stated he has made several police reports in the past.

Mann told me unknown vandals had broken the vehicle windows and damaged the cars prior to the fire on 2/26/07. He stated the fire damage was new along with some graffiti written in the snow. Mann suggested the vandals may be students from Cretin Durham Hall High School and provided the contact information for Assistant Principal Andy Bishoff (651-696-3305). Mann explained that he caught C.D.H students in the property a few years ago and said he suspected it may be the same juveniles. Mann said he wasn't present at the time of the fire, however, and arrived on scene after SPFD had left. Mann told me he took several pictures of foot prints in the snow and I explained that SPFD personnel had been in and around the entire area of the building during fire suppression and investigation activities. I explained that SPFD Investigator Minkinen had documented the scene and taken photographs as well.

I encouraged Randall Mann to contact me in the future with any questions or concerns and he agreed to pass along anything he considered to be an investigative lead.

I made several attempts to contact Assistant Principal Bishoff with negative results. I left several messages but have not received any return phone calls at the time of this writing.

Mann is the caretaker of 380 Randolph, which is a vacant building that is surrounded by a fence. He was alerted of possible persons in the bldg when motion sensors were activated. When NICHOLS and NIGHTENGALE reached a certain room in the bldg, Mann locked them inside and called police.

Officer Longen/Sqd 270 was already on scene and had handcuffed both and escorted them off the property.

NICHOLS told me the following:

- she and NIGHTENGALE were in search of a setting to use for a photography or film assignment
- she attends MPLS Community college, but is not currently enrolled
- she and NIGHTENGALE did not intend on damage or taking any property and were sorry for trespassing

I issued trespass citations to NICHOLS (#906206276) and NIGHTENGALE (#906210928) and released them at the scene.

Mann signed Citizens Arrest forms for both suspects.

AS NAMES/MONIKERS OF THE "KOK" CREW SUCH AS "KOSK, KONG, ZEAL, ACME WHICH HAVE BEEN PART OF AN ONGOING INVESTIGATION. IT IS UNKNOWN WHEN THIS DAMAGE WAS DONE. I TOOK 18 DIGITAL PHOTOGRAPHS OF THE DAMAGE. MANY OF THE WINDOWS AND DOORS HAVE BEEN BROKEN AND THERE IS EVIDENCE OF VAGRANTS THAT HAVE BEEN STAYING THERE. MANN TOLD ME THAT A MOTION SENSOR WENT OFF IN THE BUILDING AND WHILE HE WAS CHECKING THE BUILDING HE COULD HEAR SOMEONE WALKING AROUND INSIDE AND WHISTLING. MANN SAID HE LOCATED A WHITE MALE AND WAS ABLE TO LOCK HIM INSIDE A ROOM. MANN TOOK ME TO THE ROOM WHERE I TOOK A MALE LATER IDENTIFIED AS, COBB, TRACY J, 01-18-1970 INTO CUSTODY.

COBB SAID HE WAS JUST WALKING ALONG THE RIVER AND SAW THE BUILDING AND DECIDED TO GO INSIDE. COBB WOULD NOT GIVE ANY OTHER REASON FOR BEING INSIDE THE BUILDING. COBB DID SAY HE KNEW HE WAS NOT SUPPOSE TO BE INSIDE THE BUILDING.
