# **Opioid Crisis in Ramsey County**



- National public health crisis
- Drug Overdose is the leading cause of accidental deaths in the county


### **2024 Provisional National Overdose Death Data**

For immediate release: May 14, 2025

Today's provisional <u>data</u> release from CDC's National Vital Statistics System <u>shows</u> a remarkable nearly 27% decrease in predicted drug overdose deaths in 2024 compared to 2023 on average, this decline suggests more than 81 lives saved every day.


## **Opioid fatal and non-fatal overdose in Ramsey County**


#### Opioid-involved deaths by year

### **Opioid Settlement Funds**

- Minnesota is part of a multistate lawsuit against multiple opioid distributors and a manufacturer.
- Funds distributed to counties and cities over a certain population.
- Settlements resolve investigations and lawsuits against these companies for their role in the crises.

### **Other Opioid and Substance Use-Related Grant Funding**

<b>Previous:</b> \$412,627 (through June 30, 2024)	<ul> <li>Awarded by DHS for the Expansion and Enhancement of a Continuum of Care for Opioid-related Substance Use Disorders Grant Program Funds. (Opioid Epidemic Response Advisory Council – OERAC)</li> </ul>
<b>Current:</b> \$499,975 per year (September 30, 2023 – September 30, 2028)	<ul> <li>Awarded by the Substance Abuse and Mental Health Services Administration (SAMHSA) to provide comprehensive, coordinated, and evidence-based treatment and housing referrals for justice-involved and unsheltered community members with Substance Use Disorder (SUD) and co-occurring mental health conditions.</li> </ul>
<b>Current:</b> \$1.2 million (November 2023 – June 30, 2026)	<ul> <li>Awarded by DHS for Ramsey County Harm Reduction and Treatment Connection (HRTC) aimed at providing harm reduction services and treatment referrals to justice involved individuals and people experiencing homelessness through Ramsey County correctional facilities, the Syringe Exchange and Mobile Medical Unit. (Opioid Epidemic Response Services – OERS)</li> </ul>

- •Anonymous syringe exchange and disposal
- Naloxone distribution
- •Naloxone training for individuals and community organizations
- •Fentanyl and Xylazine testing strips
- •Wound care
- •Harm reduction education
- •HIV and Hepatitis C testing
- •Connection to community resources
