NOTICE OF PUBLIC HEARING

Sound Level Variances

MNUFC v Houston Dynamo FC – Minnesota United FC/Allianz Field
and
MNUFC v LA Galaxy -Minnesota United FC/ Allianz Field

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, Director, Events and Guest Experience, has requested two sound level variances, for 95 dBA at no specified distance to present amplified sound with use of a sound system for their MNUFC v Houston Dynamo and MNUFC v LA Galaxy, their MLS regular season games, on Saturday, August 7, 2021 and on Saturday, August 14, 2021 at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area – Allianz Field. The variances are requested for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. on August 7, 2021 and for the hours of 2:00 p.m. until 4:30 p.m. with a pre-event sound check at 1:00 p.m. on August 14, 2021. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. on Saturday, August 7, 2021 for the MNUFC v Houston Dynamo FC game and for the hours of 2:00 p.m. until 4:30 p.m. with a pre-event sound check at 1:00 p.m. on Saturday, August 14, 2021 for the MNUFC v LA Galaxy game. 2) All electronically powered equipment used in conjunction with the events shall not exceed 90 dBA as measured at 50 feet from all sound sources on August 7, 2021 and on August 14, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:00 p.m. on August 7, 2021 and shall be turned off no later than 4:30 p.m. on August 14, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits
