**Event:** Do Good Events on behalf of Ryder Cup European Contingency Celebration Night 2016

**Description of Variance:**

**Location:** Raspberry Island

**Noise Source:** Do Good Events on behalf of Ryder Cup European Contingency, represented by Kalsey Beach, President, has requested a sound level variance, at a requested sound level limit of 105 decibels (dBA), at an unspecified distance, in order to provide amplified music and the use of a sound system, during the European Contingency of the Ryder Cup Celebration Night from 7:00 p.m. until 10:00 p.m. on Thursday, September 29, 2016, with a pre-event sound check at 5:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for the hours of 7:00 p.m. until 10:00 p.m., with a pre-event sound check at 5:00 p.m. on Thursday, September 29, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 95 dBA at 50 feet from the sound source. 3) The applicant shall provide personnel and equipment, who will provide continuous sound level monitoring at each sound mix during the hours of the variance. 4) All electronically powered equipment, PA systems, loudspeakers, or similar devices located on the event grounds must be turned off no later than 10:00 p.m. on September 29, 2016 at the specific location.
