This email serves to communicate our strong objections to the license application for Malt on Sale (3.2) license to the existing restaurant and sidewalk cafe licenses located at 629 Aldine Street.

As a neighbor with a young child living in close proximity to Eden Pizza, our family is concerned about how alcohol consumption will affect the atmosphere in the neighborhood and how it will contribute to increased noise levels by customers, particularly those who sit outside. Already, noise levels, litter and outdoor cigarette smoke (from both customers and staff of Eden Pizza) are serious irritants and health concerns, particularly during the spring-fall season when it's necessary to have windows open. Eden Pizza's presence in this residential area of Hamline-Midway also already contributes to increased late night traffic noises around Lafond Avenue and Aldine Street, occasionally disrupting the ability to sleep peacefully after 10 p.m.

We believe that the sale of alcohol at Eden Pizza will negatively impact the quality of life of those who live in this residential section of the Hamline-Midway neighborhood and consequently, decrease property values. We would like to see Eden Pizza remain an alcohol-free establishment in order to help this neighborhood maintain a family-friendly and peaceful part of Hamline-Midway.

Please consider our objections and do not issue a permit to issue a Malt On Sale license to Eden Pizza.
