Thank you for allowing us to respond to this license request.

Habitat for Humanity is a nonprofit organization that helps families build and improve places to call home. We believe affordable housing plays a critical role in strong and stable communities.

Habitat works together with families, local communities, volunteers and partners from around the world so that more people are able to live in affordable and safe homes. Our advocacy efforts focus on policy reform to remove systemic barriers preventing low-income and historically underserved families from accessing adequate, affordable shelter.

Twin Cities Habitat for Humanity is committed to building the quality of life, health, and economic prosperity of the seven-county metro region by producing, preserving, and advocating for affordable homeownership – because homes and families are the foundation of successful communities.

One of the many aspects of our operation is to provide financial coaching to people to help them achieve those goals.

When we look at the Midway area, we see many people struggling in life. Some are houseless, many are using the local food shelves, some are trapped in addictions, some are living short and long term in the Quality Inn (indicated by the school buses picking up and dropping off children), some are in a transient period of their lives, and some are living in cars.

We appreciate the many organizations that are striving to improve lives in this area and the support we receive from the City of St Paul in so many ways. And to be clear, we do NOT have any policies against alcohol or gambling, rather we do promote financial well-being, among many other things. This area has many places already to partake in the use of alcoholic beverages, both on and off sale. This area also has opportunities to gamble via the State Lotteries, pull tabs, and charitable gambling in person or online.

All that said, we have concerns about adding those elements to a neighboring property that already has a history of safety concerns.
