They have not paid yet, but costs are being incurred. This was a staff error, and she got this information when she asked about it. The Council should seek outside counsel on this matter. Going forward, we should receive things in a timely fashion.*

*Councilmember Prince seconded that. She would like to see what is affected on the budget, because it was not included. Any impacts on Midway development, she would like as much information ahead of time as possible.*

*Councilmember Bostrom said this is similar to the ballpark when they got a bill that was not talked about ahead of time. They have to keep track of this. The Council needs to know about cost overruns.*
