I recently spoke to with Councilmember Dave Thune's office about a problem property across the street from me, and suggested I contact you. The bar 'Tavern on the Avenue' located at Jefferson and Fulton has had repeated incidences of violence, drunk and disorderly contact and noise violations for the past four and half years that I have lived here. I have done everything up until this point to try and remedy the problems: I attended the first hearing when the bar changed owners and wanted to extend their liquor license where I raised concerns and was given a promise by the manager and owner that things would improve. I have called the manager and bar staff repeatedly about fights, then decided to just directly call the police. When I purchased my home, I knew there would be a fair level of noise. I work at a bar and know the nature. But there has been a total disregard for the neighborhood and the residents that live here. The fights bother me the most, because they go far beyond what the security can control. Last call when the parking lot fills is the worst time of night (2-3 a.m.) when people continue shouting, playing loud music and generally having an after party with no word from the bar security. Fights have escalated to include almost four dozen people. These usually spill into the street and move toward my home. When I call the police, I feel as if they don't take it seriously unless there has already been an altercation, even if one is
