Debbie Mazurkiewicz (899 Case Avenue) expressed frustration about the way City staff handled a sewer problem the City identified at her house, and about the assessment associated with it. She said a company blew out the sewers in the fall of 2010 and the sewers broke as a result of problems that occurred during that work. She said she felt she was being targeted, and it was a City problem not a homeowner problem.

Chu Yang, son of Youa Pao Yang (895 Case Avenue), echoed the concerns expressed by Ms. Mazurkiewicz. He said a lot of homeowners were affected when the contractor broke the sewer, and he questioned whether that was normal. He said seven properties had permit holds due to sewer problems, but only one property owner had been notified. Council President Lantry noted that the assessment being considered had only one address.

Public hearing to consider the appeal of Rene and Rachel Lerma to a decision of the Planning Commission to approve a conditional use permit for a wind turbine at Metropolitan State University.

Kate Reilly, Planning and Economic Development (PED), gave a staff report. She said the Zoning Committee's recommendation to the Planning Commission was to deny the application for a conditional use permit due to the location of the proposed wind turbine adjacent to a historic district. The Planning Commission rejected the recommendation and voted to approve the conditional use permit.

In support of the appellant:

Appellant Rene Lerma (613 North Street) read a statement voicing his opposition to the Metro State wind turbine. He said it did not belong in a residential district and presented numerous issues when weighed against any benefit presented by Metro State. He expressed concern about Metro State's failure to notify the community about the planning process. He said he felt the Planning Commission's comparison of a wind turbine to a free-standing cellular tower was flawed, as was the comparison of Metro State's proposed wind turbine to the one at Macalester College. He stated that the wind turbine would detract from the otherwise carefully regulated historic nature of the area, and would have a negative impact on area wildlife. He questioned moving forward with the wind turbine before setbacks or guidelines were established. He said he supported alternative energy but felt solar or geothermal would be more appropriate options for Metro State.

Rachel Lerma (613 North Street) submitted a petition with signatures of over 70 Dayton's Bluff residents opposed to the wind turbine, and read a statement of opposition. She stated that Metro State's plan indicated a plan to install the wind turbine in either a side or front yard, in violation of a zoning/planning stipulation. She noted that the site plan placed the wind turbine on another side of the building from an existing cell phone tower, which was subject to the same stipulation. She reiterated several points raised by Mr. Lerma, and spoke about potential health and safety hazards to residents and to students at a nearby school. She said the location of the wind turbine violated rules in Dayton's Bluff Historic District handbook related to key views and vistas. She expressed concern that similar proposals would be approved in other areas of the city if this one was allowed to go forward.

Cliff Carey (635 Bates Avenue) said he supported the appeal and felt the Planning Commission erred in their findings as to the effect of the wind turbine on the surrounding neighborhood. He said Swede Hollow Park was a unique area in the city, and the wind turbine would add to the visual pollution created by the two existing cellular towers. He said he objected to the specific location chosen by Metro State because it was the one that most affected the park.

Jean Comstock (729 East 6th Street), representing the District 4 Dayton's Bluff Community Council, stated that the Council had voted to send a letter in opposition to the wind turbine, particularly after hearing the strong opinions of the neighbors.

Matt Mazanec (761 East 6th Street), East 6th Street Block Captain and member the of St. Paul Heritage Preservation Commission (HPC), said he was in favor of Metro State being in the community and of renewable resources, but had serious concerns about the project, the primary one being the strong community opposition. He reiterated concerns expressed by others.

In support of the applicant:

Jesse Bethke-Gomez, Vice President for University Advancement and Executive Director of the Metropolitan State University Foundation, described the proposed

turbine, its use for research, and its location, noting that it was in a B2 Community Business District. He said they appreciated the needs and concerns of the community and hoped the wind turbine would add to the vibrancy of the East Side as a standing symbol for science and technology education and the St. Paul's commitment to innovation and to inspiration for kids. He referred to and summarized information in materials provided to Council members by Metro State staff, and responded to concerns expressed by previous speakers. He introduced Patrick Hamilton, Director of Global Change Initiatives in the Science Learning Division at the Science Museum of Minnesota.

Patrick Hamilton discussed the strong educational benefits of the project.

Mr. Bethke-Gomez made concluding remarks about Metro State's commitment and contributions to the Dayton's Bluff community.

Council President Lantry moved to close the public hearing. Yeas – 6 Nays – 0 (Carter not present for vote)

Council President Lantry said regulations governing wind turbines were still being developed, and the Planning Commission had used the guidelines that apply to cell phone towers. She said the issue was not about Metro State or science education but whether a cell tower antenna was comparable to a wind turbine. She moved to grant the appeal, stating that the moving parts on a wind turbine made the comparison to a cell tower invalid. She said a wind turbine was not comparable to a cell tower because it had moving parts, and even if it were, the proposed turbine would not meet existing cell tower standards in terms of height and design.

Councilmember Thune agreed that such a large structure was not appropriate and said he shared concerns about precedent if this was approved. He asked about alternative options for Metro State to showcase their science program.

Councilmember Brendmoen asked how a decision could be made on Metro State's proposal when there were no standards for wind turbines, and wind turbines were not comparable to cell towers. Council President Lantry said the most comparable situation was the wind turbine at Macalester, which was shorter and located so it was not visible from the street.

Councilmember Stark said it wasn't clear whether this fit the spirit of the existing zoning code and was a judgment call, and for a lot of the reasons mentioned, particularly because guidelines were being developed for this kind of use, he would support the motion.

Final Order amending a portion of Public Hearing Resolution #10-471, approved on May 5, 2010, for the construction of bicycle facilities along Jefferson Avenue from Colborne Street to Mississippi River Boulevard. (File No. Jefferson'10)

Councilmember Tolbert moved an amendment changing the type of pavement markings on Cretin and Cleveland, changing the type of pedestrian crossing sign at Cleveland and Cretin, and eliminating traffic circles at Wheeler and Macalester Streets. He said he felt it was a reasonable solution to the five-plus years of public comment. Councilmember Thune added to the amendment to include a traffic circle at Jefferson at Duke and lighting under the Victoria bridge at Jefferson. After receiving clarification from Councilmember Thune, Councilmember Tolbert accepted the addition.

Councilmember Stark said he supported three of the four components of the amendments but felt retaining the traffic circles was important in completing the project. He said he would support the amendment.

Paul St. Martin, Public Works, said Public Works was okay with the additional traffic circle at Jefferson and Duke. He said added lighting on Jefferson under the I-35E bridge was already part of the project, but Victoria under the I-35E bridge was outside of the limits of the federally funded project and adding it would require finding another funding source. Councilmember Thune removed that portion of the amendment.

The amendment was introduced. Yeas – 7 Nays – 0

Councilmember Stark requested a brief staff report.

Emily Erickson, Public Works, gave a staff report summarizing the process and project. She said the department had received 87 comments, most in support of the bike way project overall, and many expressing appreciation for the City's responsiveness to community concerns. She said the two most controversial issues were traffic circles and two-sided parking.

In opposition:

Gary Fischbach (567 Saratoga Street S.) said it was a lot of money to spend on a project that not everyone wanted, during a time of rising taxes and government cutbacks.

Dede Leininger (2159 Juliet Avenue) echoed Mr. Fischbach's concerns about cost. She said she was in favor of bikes on Jefferson, but the changes to the street were unnecessary, and would continue to require maintenance after the federal grant was gone.

Colleen Kelly (1803 Juliet Avenue) said she resented having her neighborhood being used as a social experiment and objected to the piecemeal physical alteration of the roadways without an overall plan. She said the issue of City's liability with traffic circles had not been addressed.

Larry McIntyre (property owner at 2071 Jefferson) objected to the expenditure of additional funds to change the character of Jefferson at all. He said changes were not needed to accommodate bike traffic, and he shared Ms. Kelly's concerns about adding traffic calming devices without a firm plan. He said the special pedestrian signals were nice but had nothing to do with bike traffic and he didn't feel they would not be utilized by bikers.

In opposition to the amended version:

Brian Valento (333 Macalester) said he was in favor of the project with the exception of the traffic calming devices, which he objected to on the basis of their disruption of the architectural integrity of the neighborhoods and safety concerns.

Jessica Treat (1509 Lafond Avenue), Executive Director of St. Paul Smart Trips, said she was opposed to the amended resolution and supported the design recommended by the Planning Commission. She said her organization was concerned about going beyond "good enough" to encourage people to bike and walk more often by making it the safe and easy choice. She said calm safe streets were a goal of both supporters and opponents of the project, and traffic circles had been demonstrated to be better at calming traffic than stop signs. She said the proposed amendments subverted the extended public process and the advice of City staff, and asked that the matter at least be laid over.

Council President Lantry said there had been confusion about signing up to testify because some people were in opposition to the amended resolution but not the resolution itself. She said each person opposing the amendment would be allowed two minutes to testify. Some in attendance expressed frustration that the amendment had not been made available before the meeting.

Amber Dallman (1328 Sargent) said providing facilities like the bicycle boulevard on Jefferson with the recommended design from City staff and the community's input, supported calming traffic and facilitated better, safer movement for people choosing to walk or bike on Jefferson. She asked that the matter be laid over so the amendments could be considered.

Deb Jessen (1878 Jefferson) said she was a proponent of the bike lane and adamantly against stripping the traffic calming measures from the proposal. She said City officials had bowed to the pressure of the "squeaky wheel of the opponents" and gone against the reasonable, factual and professional arguments in favor of traffic calming and the benefits of increased biking and walking.

Patrick Campion (1880 Jefferson) expressed disappointment that over the past two years Minneapolis had doubled the number of bike lanes and bikeways while St. Paul tried to get one started, but said it also provided a practical example of what could and should be done. He said he was also disappointed by the eleventh hour amendment after a long and engaged process.

Elizabeth Fable (1880 Jefferson Avenue) thanked Public Works staff, especially Emily Erickson. She questioned the removal of traffic circles between Fairview and Cleveland when they were considered safe and effective from Snelling to Fairview and from Cleveland to the Mississippi River. She said she opposed the amendment and was disappointed that even more traffic circles were being dropped.

Robert Spaulding (1153 Churchill Street N.), representing the Transportation Committee of the Planning Commission, said the Transportation Committee had been established by the Council in 2010 to monitor and advance the Transportation Chapter of the Comprehensive Plan, and the project addressed a theme that ran through the core of the plan. He reviewed the process leading to the approval of the project.

Dave Pasiuk (1984 Jefferson Avenue) said 23 meetings had gone into the project and it was all done away with by one amendment. He said he did not feel that was appropriate given all of the input and trust in the process by the community.

Christopher Johnson (1801 Jefferson) echoed the sentiments expressed by Mr. Pasiuk. He said the repaving and removal of trees on Jefferson between Snelling and Fairview encouraged speed, and a traffic circle at Wheeler would make it look less like a throughway. He thanked the City engineers and sustainable transportation planner for their work on the plan.

Jeff Zaayer (1750 Saunders Avenue) said he as a proponent of the bikeway but felt the amendment undermined the community process and recommendation of the Planning and Transportation Commission as presented by Public Works.

Paul Nelson (1678 Van Buren Avenue) said he was very supportive of the Jefferson Avenue Bike-Walk Project but did not support the amendment. He said projects of this kind recovered and restored the public function of public right-of ways that had been lost in the past 100 years.

Mary Karlsson (1717 Jefferson Avenue) commended staff on the welcoming, inclusive, and productive process, and stressed the importance of focusing on innovation in transportation. She said she very much wanted to see the project with the traffic circles implemented.

Joyce Krech (1696 Jefferson Avenue) said she supported the original proposal and opposed the removal of the two traffic circles.

Andrew Ostenso (1456 Berkeley Avenue) said he was very much in favor of the Jefferson Avenue Bikeway, but removing the elements that made a bikeway a bikeway was not in the best interests of the City or community.

In support:

Andrew Singer (2103 Berkeley Avenue) said there was data supporting the effectiveness of traffic circles and he liked them, but he felt the amended plan retained the core elements of crossing aids at Cretin and Cleveland.

Jim Skoville (2093 Jefferson Avenue) said there was very little traffic between Cretin and Cleveland, and their concern was safety for people with mobility limitations. He said they were in favor of the additional pedestrian accommodations at Cretin and Cleveland included in the amendment.

Oriana Leishman (2183 Jefferson Avenue) said she and her husband participated in the process, were happy their concerns were heard, and supported the project. She said they were particularly in favor of the change to pedestrian activated lights from continuously flashing LED signs, which would have been intrusive. She said the amendment might not satisfy everyone's concerns but was still for the betterment of the community.

Mike Jones (3240 Fremont Avenue S., #208, Minneapolis) said he biked regularly from Minneapolis to St. Paul. He said he was in favor of the proposal without the amendment, but didn't want to see it disappear all together.

Councilmember Tolbert moved to close the public hearing. Yeas – 7 Nays – 0

Councilmember Tolbert said it had been a long public process and he thanked everyone for coming to give their testimony and their engagement. He acknowledged that there were a number of viewpoints, but said overall the neighborhood had the opportunity to be heard and Public Works had done a good job

of hearing and responding to concerns. He discussed the effect of the amendment on use of the federal funding, and stressed the importance of being good stewards of taxpayer money.

Councilmember Stark said it was time to move forward with the project even though it wasn't perfect.

Councilmember Tolbert moved to adopt the resolution as amended.
