Legal Description of Proposed Sewer Easement within WEST SIDE FLATS (June 29, 2017)

That part of Lot 1, Block 2 and Outlot B, WEST SIDE FLATS, according to the recorded plat thereof, Ramsey County, Minnesota, lying southwesterly and southerly of the following described line and its northwesterly extension:

Beginning at the most easterly corner of said Lot 1; thence North 30 degrees 52 minutes 17 seconds West, assumed bearing, along the northeasterly line of said Lot 1, a distance of 249.48 feet; thence South 66 degrees 59 minutes 33 seconds West, a distance of 42.51 feet; thence North 45 degrees 20 minutes 48 seconds West a distance of 98.23 feet; thence North 73 degrees 14 minutes 27 seconds West a distance of 53.08 feet; thence South 36 degrees 01 minutes 53 seconds West a distance of 33.41 feet; thence North 52 degrees 29 minutes 09 seconds West a distance of 25.7 feet, more or less, to the shoreline of the Mississippi River,

lying northeasterly and northerly of the following described line and its northwesterly extension:

Beginning at said most easterly corner of Lot 1; thence northwesterly, along the southwesterly line of said Lot 1, being along a 150.00 foot radius curve, concave to the southwest, a delta angle of 51 degrees, 53 minutes, 34 seconds, a chord bearing of North 56 degrees 49 minutes 11 seconds West, a distance of 135.86 feet, assuming said northeasterly line of Lot 1 has a bearing of North 30 degrees 52 minutes 17 seconds West; thence North 44 degrees 53 minutes 08 seconds West, not tangent to said curve, a distance of 70.04 feet; thence South 64 degrees 31 minutes 58 seconds West a distance of 30.08 feet; thence North 29 degrees 41 minutes 16 seconds West a distance of 77.95 feet; thence South 40 degrees 19 minutes 52 seconds West a distance of 81.74 feet, to said southwesterly line of Lot 1; thence northwesterly, along said southwesterly line, being along a 175.00 foot radius curve, concave to the southwest, a delta angle of 19 degrees 51 minutes 19 seconds, a chord bearing of North 68 degrees 24 minutes 40 seconds West, a distance of 60.64 feet, more or less, to the southwest line of said WEST SIDE FLATS; thence North 31 degrees 00 minutes 09 seconds West, not tangent to said curve, along said southwest line, a distance of 34.87 feet; thence North 03 degrees 23 minutes 53 seconds East a distance of 35.30 feet; thence North 47 degrees 31 minutes 22 seconds East a distance of 8.48 feet; thence North 52 degrees 29 minutes 09 seconds West, a distance of 40.8 feet, more or less, to the shoreline of the Mississippi River,

and lying southeasterly of the shoreline of the Mississippi River.
