Tennis has a contract with Canterbury Homeowners Association. I am a 79 year old veteran with a disability on a fixed income, I have received medical assistance from Ramsey County since 1996 and have a long term arrangement to share a trash can with a friend to save money. My friend lives in Woodbury. Since I don't use St. Paul trash service I should be 100% exempt from the exorbitant trash bills. I don't own a car, I ride a bicycle, I avoid debt and unnecessary expense like St. Paul trash. St. Paul failed to negotiate a favorable low cost contract with the haulers and the citizens must pay twice as much as the City of Maplewood citizens pay for trash service.
