

Dear Property Representative:

An inspection was made of your building on September 18, 2020 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately.

## A re-inspection will be made on or after September 25, 2020.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

## **DEFICIENCY LIST**

- 1. #21 - Southeast Window - SPLC 34.09 (4), 34.33 (3) - Repair and maintain the window glass.
- 2. #21 - SPLC 34.23, MSFC 110.1 - This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.-Unit is condemned due to but not limited to tampered electrical meter, no power, no working smoke alarms, and no working carbon monoxide alarms. Unit must be immediately vacated.
- 3. #21 - MN Stat. 299F.362 - Immediately provide and maintain a smoke detector located outside each sleeping area.
- 4. #21 - MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturers instructions.

5. Laundry Area - Electical Meter Box - MSFC 605.1 - Repair or replace damaged electrical fixtures. This work will require a permit(s). Call DSI at (651) 266-8989.-Repair electrical meter that has been tampered with under permit by a licensed contractor.
