Ms. Constantino,

I hope you are well. We've received your inquiry on removing garbage assessments on your property at 1282 Hague Ave from July 2019 – December 2020.

Since all garbage assessments before Quarter 4 2020 have been levied to your taxes, you are not able to an appeal through the City's assessment hearing process. For each assessment you were sent two delinquent notices and a final notice of non-payment from your hauler. Once the assessment was turned over to the City, you would have received two additional notices of the pending amount from our assessment office. These letters notified you and outlined the process to contest the assessment at a scheduled legislative hearing or at City Council. Any assessment(s) not appealed with Council was ratified and approved and sent to the County.

If you would like to request a legislative hearing to appeal your Quarter 4 2020 assessment, please fill out the online legislative hearing request form here:

Additionally, if your property is currently vacant (and may be for an extended period of time), I request that you fill out our unoccupied Dwelling Registration Form. This will stop service at this property. I have attached this to my email.
