City Council This is the time for austerity in the city budget. The city council's leadership is needed to curb overspending and prioritize basic city services. I will attempt to guide places for cuts. These approaches are not meant to question whether existing initiatives are of value, rather they are testament to the fact that citizens cannot afford to pay for them on top of increases for insurance, utilities, food, water, sewer service, and sales taxes.

The city council must go through each line item of the budget, with an emphasis on reducing staffing. It's necessary to decrease the number of positions as civil engineers, administrators, managers, and staff in marketing or recruiting. Place a hiring freeze along with no replacements when a vacancy occurs. Staff for any programs that were initiated in the past four years should be reevaluated. Additionally, list all jobs with a salary over \$65,000 and assess the following:

- Is this a new position during the past four years?
- Is this position in the mayor's office, marketing, diversity programming, recruiting, human resources, or administration?
- What is the direct benefit to the citizens from these higher paid positions?
- Can these positions be restructured or cut entirely?

Use the assessment to determine if these positions can be cut entirely or restructured. Reduction in federal and state funding to cities necessitates staff layoffs, reorganization of city departments, and consolidation of services.

Beyond staffing, clear priorities within departments are necessary.

- **Public Works** - Stop street cleaning before the leaves fall. Fill pot holes in a timely manner. Plow when snowfall comes to three inches, and plow before it ices up.
- **Parks** – Charge a sizeable usage fee for every special event that closes city streets and parks. Water trees that are city owned, replace dead trees, don't remove healthy trees. Clean up trash in parks. In the parks patrol theft, violent behavior, gangs and drug deals. Do not allow unhoused people to live in public parks.
- **Recreation Centers** - Offer more services and programs for older adults. Reduce Recreation Center hours. Cut classes and programs that do not have a sizeable attendance.
- **PED** – Stop acting as the direct arm of the mayor's vision for economic development when it's in direct conflict of neighborhoods quality of life. Pass MRCCA. Use gentle density for building in residential neighborhoods. Focus on home ownership verses all rental units. Also, bring back businesses that are job creators verses just building luxury apartments .

- **Police** - Provide direct presence in all neighborhoods. Bring back neighborhood policing on foot and stationed in recreation centers, libraries, parks, sidewalks in front of businesses. Vacate those who are living or panhandling on public property.
- **Libraries** - Eliminate practice of having two deputy directors (necessary todo this in all city departments). Consolidate bilingual story times. Increase usage of volunteers for homebound delivery. Reduce library hours. Turn on the theft detection devices to stop stolen materials. Charge all groups except libraries for the use of meeting rooms. Sunset all grant funded positions/programs when the grants end. Fund social workers/mental health specialists through Ramsey County rather than with city funds. Assess consolidation of the city and Ramsey County library systems. Enforce public code of conduct for all who enter the library.

The solution to our overextended budget is to lead with fiscal responsibility and effective use of staffing and programs. Concentrate on basic city services with no excess or duplication of county services or special programs. These are too expensive to maintain. We shouldn't be increasing, or even maintaining, the high number of city employees as our city's population has decreased.

I believe many other residents share my perspective, and I encourage them all to contact you with their budget suggestions and remarks.

Mayor Carter, you have served us well in your time leading the city of Saint Paul and I'm proud to have voted for you every chance I got. I was impressed by the largely progressive values you ran on, but these budget cuts to our city workers are regressive and emblematic of the issues that drove Mayor-elect Her to victory. I fear you may have fallen out of touch with the needs of our neighbors as these priorities are not aligned with the community values that won my vote.

Reducing library hours on the East Side means leaving ordinary families out in the cold, cut off from access to the community services our children use to thrive like quality library programming, computer access for homework and research, books for families to read offline together. Cutting hours for third spaces like public libraries disproportionately harms families who work long hours to feed their families and pay their fair share in taxes to make Saint Paul a great place to raise our kids.

Recreational centers offer kids a healthy outlet for after-school physical activity and socialization, and cutting their hours means isolating our kids during a youth mental health crisis. These services mitigate public safety risks and you did not run on making our city less safe.

I cannot fathom why you would not value the work of the EMTs on our overnight Basic Light Support team. I've seen them save lives so I find it hard to believe you've never seen what they do for us in all your years as our mayor, and frankly it makes me angry to think you would show our youth that we don't even value the labor of emergency healthcare and fire department workers who want to serve our city. Our EMS are critical infrastructure. How much is a human life worth to you?

Please do not betray our city workers in the twilight of your term. You've been someone we can rely on for all these years, and we need you now to restore crucial funding to our city.

Dear Chair Yang and members of Saint Paul City Council:

On behalf of Twin Cities Habitat for Humanity, I am writing to share our comments on Mayor Carter's 2026 Proposed City Budget. In today's unpredictable environment, strong local partnerships are more vital than ever to ensure the success of current and future affordable housing developments across Saint Paul.

We take great pride in our decades-long partnership with the City of Saint Paul, which has only grown stronger over the past year through The Heights – a transformative development that is converting a former golf course into a vibrant neighborhood centered on clean energy and long-term affordability, benefiting generations to come. In just one year, 60 homes are actively under construction; 11 reservations have been made, and the first homeowners are set to move in soon.

The significant financial and other support of the 147-unit Heights neighborhood is indicative of our collective understanding of the dearth of affordable homeownership options in the City and throughout our region - new homes, acquisition and rehabilitation of existing homes, and the preservation of existing homeownership by low-income households.

The data is clear regarding the long-term positive, generational impact of affordable homeownership on families' education, health, and financial outcomes. Because of the City's tremendous support, we have partnered with over 450 families since 1985. In order to continue our work for Saint Paul residents, we need the City's support more than ever to confront headwinds facing the entire industry. Total developments costs have increased 6-12%, with rising tariffs creating additional pressures.

With the sunseting of the Inspiring Communities program, we see a timely opportunity to develop a flexible successor initiative that supports the **development of new affordable homes** on vacant lots, including HRA-owned lots, as well as the **acquisition and**

rehabilitation of existing homes to increase the supply of quality affordable owner-occupied homes.

With consistent and sufficient investment and accessible resources, a robust program could provide developers with a reliable pathway to create and preserve affordable homeownership throughout the City.

The proposed charter amendment allowing administrative citations for code violations represents a significant shift in how the City can address housing concerns short of criminal charges. This change is largely positive and will likely be an effective tool. That said, there are risks due to financial penalties that can unintentionally deepen the challenges faced by homeowners already under financial stress.

To mitigate these risks, we urge the City to consider a partnership-based approach that connects income-eligible homeowners with critical home repairs. Twin Cities Habitat's *A Brush With Kindness* program has successfully implemented this model in Bloomington and Minneapolis, helping stabilize homeowners at risk of displacement and preserving the existing housing stock. The majority of homeowners served through these partnerships have incomes at or below 30% AMI, and eligibility extends to those earning up to 80% AMI.

Our experience shows that citations can be addressed through supporting homeowners to make necessary fixes, rather than further disenfranchising them with unaffordable penalties. If and when City leaders would like to pilot this model in Saint Paul, we would be eager to talk further. Together, we can ensure this policy change uplifts rather than burdens the city's most vulnerable homeowners.

We are committed to continuing our close partnership with the City of Saint Paul and look forward to working together to create and preserve affordable homeownership opportunities across the City.

Subject: Closing Rondo Library

Dear councilmembers,

My name is Alice and I am a Library Associate with Saint Paul Public Library. From 2018 to early 2025 I worked as the Teen Specialist for the Rondo Library branch. I lived in ward one for many years; I now live in ward four and work in ward two.

I am writing in support of CM Bowie's amendment to ensure that Rondo Library does not close without a clear plan and genuine engagement of community and staff.

CM Bowie informed clerical, reference, and safety staff that this renovation has been presented to council as being asked for by us. Having been at Rondo during the years these conversations began, I know how inaccurate that is. Over the years as we've been handed top-down responses to substance use from administrators not working in the building, my frontline coworkers and I have repeatedly emphasized that none of these strategies will be effective in stopping substance use at the library without true investment in our very community members who are affected. As we've adapted to interventions like fencing, police patrolling the space, and now this plan to renovate, we've consistently asked for more resources for patrons alongside these band-aid approaches, but been dismissed. My colleagues who remain at Rondo have said over and over that if admin's renovation plan is indeed going forward, then there at least needs to be real community and frontline staff engagement instead of a design created in secret by people with little to no knowledge of the space and neighborhood.

There is so, so much more I could say, but it's impossible for me to summarize these last

few years or to touch on every facet of this renovation that needs unpacking. To name only a fraction of what concerns me: the very minimal and last-minute information Rondo staff have received throughout the process, the unfulfilled promises of staff and patron involvement in design, the disastrous consequences for the University and Dale intersection to have an empty public building for at least a year, the likelihood that without a clear plan in place this renovation will be dragged out longer than expected, the difference in community engagement avenues that the Rondo neighborhood has received compared to the current and upcoming renovations in other neighborhoods, the painful irony of overriding public concern to close down a library that is named after a neighborhood torn apart by a construction project the city forced on residents. There is so much here that the council should have been engaging in long ago rather than at the last minute. But what you still can do is ensure that community and staff concerns are being heard, that a clear plan is made before closure, and that the expertise of people who know the library and neighborhood best is included. I see CM Bowie's amendment as one step towards reducing the harm that this renovation could cause and towards centering the community and frontline experts who have been excluded from the process.

Frankly, I worry that writing to council is more likely to lead to retaliation than action. I feel compelled to write, though, firstly to correct the narrative that this plan has come from Rondo staff and secondly to stand in solidarity with my fellow community members and patrons I've worked with over the years who are calling attention to the harm that this closure will cause, especially if it continues without meaningful engagement or clear plans.

On behalf of the 1,600+ members and affiliates of the St. Paul Area Chamber, I write to urge the City Council to prioritize core government services and fiscal discipline in the 2026 budget. We acknowledge the Mayor's effort to limit the levy increase amid rising demands on local government revenues. Rising costs necessitate restraint and a focus on the services that residents and employers depend on to live, work, invest, and play in Saint Paul.

To that end, the proposed budget includes several investments that move the City in the right direction. The five million dollars for office-to-residential conversions signals a willingness to confront the challenges facing downtown and prioritize growth strategies. With downtown office values dropping, diversifying our property tax base is critical for fiscal stability. The allocation for the PAULIE permitting platform will further streamline the approval process and create a stronger climate for employers investing in Saint Paul. These align with the Chamber's commitment to a competitive, reliable environment for job creation and economic growth. While these investments are positive steps, gaps remain in areas around public safety.

The Chamber strongly believes next year's budget must support two Police Academies. Chief Henry clearly outlined the high number of retirements expected within the next five years. Delaying investment in recruitment and training may yield short-term savings, but it will create long-term staffing shortages that carry higher financial and public safety costs.

The Chamber's top priorities remain a business-friendly city, strong core services, and a dependable public safety system. Mayor-elect Her underscored this approach when she said, "To make Saint Paul work for its residents, we need to get the nuts and bolts of running a city right, so that we can welcome residents, businesses, and

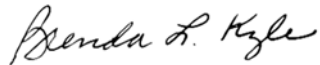


development to expand our tax base and get our city moving again." The Council needs to advance that vision as it works through the 2026 budget.

We urge the Council to prioritize core government services and fiscal discipline in the 2026 budget. COMMENTS TO CITY COUNCIL FOR TRUTH IN TAXATION HEARING

Please keep St Paul affordable for all residents. Recent property tax, sales tax, water utility, and franchise fee increases make the city less affordable for most people. Reduce the overall levy to no more than 2%.

My recommendation is to fund the core functions of the city at the current inflation rate, about 2.6%, to ensure these services are adequately provided for and maintained. By core city services, I mean police, fire and emergency services, public works, parks and recreation, and housing.

All other programs that are not core services should be reevaluated for phasing out or elimination, especially if they duplicate services already provided for by other governmental agencies in order to achieve a reduction in the overall property tax levy to the 2% level. Outlined below are several actions the city council can take to reduce the property tax levy.

Decertify any Tax Increment Financing District that has paid off the loan the city took to give the developer money for the project. This will redirect those property tax dollars to the general fund and reduce the levy for not only the city, but the county and school district.

Eliminate the \$5M proposed by the mayor to convert office space to residential use in downtown. The city should not subsidize the reduction in the market value of downtown property resulting in generating fewer property tax dollars to the general fund since residential properties pay at a lessor rate than commercial properties. This proposed expenditure does not make any financial sense in the short or long term. The city should be creative and explore other options to entice businesses to fill the office space in downtown at a lessor cost.

Pause spending revenue from the 1% sales tax for new park facilities. Redirect that revenue to reducing the current multi-million dollar maintenance backlog on parks and park facilities. Evaluate how the city will pay to operate and maintain these new facilities given that the city does not have sufficient funding to properly operate and maintain its existing parks and recreation facilities. Do we need new park facilities when the city's park system is already ranked 5th in the nation and the city is under financial stress?

Request the state to fulfill its obligation to pay for its share of operating and maintenance costs for regional park facilities. Currently the city receives only about \$1.5M of the \$7M it is due.

Reassess the many positions supported by federal government aid to the city during the COVID pandemic to determine their need and alignment with core municipal services. Freeze all current vacant positions.

Focus the budget on problems that are your responsibility, mainly the core services cities must provide. Over the past decade the mayor and council have offered social welfare programs to residents. While these programs are important and valuable, they are not the responsibility of the city to provide. Social welfare programs are the responsibility of the federal, state, and county. As much as the city would like to solve all the problems within its boundaries, it does not have the responsibility, money, nor expertise to do so. Stepping in to help in these areas only allows the federal, state and county governments to avoid their responsibilities.

Keep St Paul affordable. Thanks for your consideration.

I am writing to voice my outrage at the huge increase in my property tax for the city of St Paul.

First off, the value you put on my house, I would never be able to get if I sold my house. I highly doubt it would even get approved for a mortgage at the amount.

Secondly, your so called trash hauling, that was supposed to be so much better and less expensive is most definitely not in any way, shape or form less expensive or better.

1) the trucks are a lot bigger than any of the trash haulers we've had, weither they were of our choosing or what you forced us to use. They are exponentially heavier, noisier, and harder on our streets and trash cans.

Last Monday they picked up in the morning (the racket they made could wake the dead.). I heard and saw them again around 3 pm, going down our street (our street is a block and a half long) at a very high speed for no reason.

2) I have seen so many of the trash cans on our street that have been destroyed by the new service, within weeks of them starting to pick up trash.

3) we are constantly being charged for replacement containers. I got the smaller container while we still had the independent company, but still get charged a replacement fee on my bills.

The City of St. Paul needs to be finding ways to *reduce* rather than raise homeowners' property taxes- maybe by not cutting \$74 million property tax reduction sweetheart deals for developers of the Highland Bridge project, perhaps? And not reducing the rate of growth, but reducing the actual dollar figure.

Have you considered exploring setting up an Urban Wealth Fund to leverage city-owned properties to generate revenue? The old model of property taxation is simply no longer viable- my property taxes have gone up 66% between 2021-2025 and are set to go up another 9.2% for next year. My income, on the other hand, is down over that same time. The costs of groceries, homeowner's insurance, auto insurance and almost everything else are up. The City Council members and the mayor may have enough money to shrug this off, but most St. Paul homeowners are not in that situation. St. Paul needs an alternative way of funding itself.

Only 40% of St. Paul residents own where they live (which means 60% of St. Paulites do not have stable, secure housing- rental is neither). This is an astonishing failure. A city in which the majority of homes are rental is in a moral and economic crisis which unfairly burdens BIPOC residents in particular. Black home ownership in St. Paul, for example, is a mere 26% compared to 46% in 1960.

What do St. Paul's citizens get for their property tax dollars? A failed downtown, streets that are cratered, terrible snowplowing, street lights that don't work*. In terms of budget priorities, fund infrastructure! As the Chinese proverb wisely says, "if you want prosperity to arrive at your door, first repair the road." There is literal as well as metaphorical truth to this.

* Regarding streetlights, weld the access panels shut to keep people from stealing the copper wiring. If the wiring is correctly done, access is not needed because no repairs should be necessary. Regulate the sale of copper to scrap metal dealers by requiring proof of source, as has been done with catalytic convertors (ultimately a state issue rather than a city/county issue but you could start there). And stop using those horrible purple lamps in the streetlights. My God, those are awful. It's like the 60s and blacklight posters are back.

Public comment for City Council 2026 budget considerations:

Like many of my neighbors on my block, I am at a loss for the proposed increase in market value for my residence, both estimated and taxable. Estimated value has increased by nearly \$42,000 (from 401,222 in 2025 to 443,187 in 2026).

Based on home improvements, my last planned improvement was installation of a rooftop solar energy system in 2024. In 2025, our insurance company did authorize a roof replacement due to hail damage.

Beyond this, our block has been part of the neighborhood renovation, receiving improvements in sewage and a new sidewalk on my side of the street. I don't know whether this figures into the value increase. On the debit side of property value, is the loss of mature trees on my block (including one in front of my house).

I would appreciate a reconsideration of the taxable market value, which has resulted in an 11.07% increase in my total tax for 2026. Without further explanation, this seems excessively high, especially when I look online at the range of suggested current market values for my property.

I would like to submit the following comments after opening my proposed property tax increase of 8.48% from 2025:

1. Government wasteful spending and fraud are out of control. Ramsey County has the highest property taxes in the state, especially St. Paul. As wealth is driven out of Minnesota especially from businesses, spending needs to be cut not increased.
2. Ramsey County gave \$38.4 million to 213 non-governmental organizations the past year, some fraudulent. This money should not be taken out of property taxes. See Liz Collin's coverage on this at alpha news.
3. The overuse of tax incremental financing (TIF) in St. Paul is contributing to sky rocketing property taxes now and well into the future. This must be curbed immediately.

Dear St. Paul City Council,

I was born and raised in St. Paul and bought a home in the city in 1998. I moved to the city since taxes and house prices were reasonable. However, that is no longer true.

I own a 1924 home that, after doing renovation, is about 1250 square feet on a standard city lot. I reviewed my tax statements from 2018 to the recent *proposed* tax statement for 2026. In 2018, my taxes were \$3100. The recent statement is \$6,164 which does not include the recycling and solid waste costs (\$215.62 in 2025), nor the school levy that passed. Therefore, my tax statement will be about \$6700 once all taxes and fees are applied if the County and City pass the proposed tax levy. This will be an increase of over \$1,000 from 2025 (3 years ago my taxes went up \$860). THIS IS UNAFFORDABLE!

I would appreciate the Council not saying to people, "Please file a Property Tax Refund." This appears to be a common misnomer by politicians that this fund makes it acceptable to raise taxes beyond what the community can carry. Although a homeowner can apply for the refund, that refund only helps for one year. However, the taxes stay high and just keep going up while a property owners' ability to get tax relief is unattainable. I have applied for these refunds throughout the years but, as you can see, my taxes have doubled in six years, while my income has not.

I would also like the Council to address the cost of recycling. In 2022, recycling was assessed at \$60.24. In 2023, the assessment was \$129.42. What happened to double the cost of recycling? In 2025, the assessment was \$172.76. So, in 3 years, recycling costs have nearly tripled.

Another cost to consider is the line item, "Economic Development and Housing". From 2022 to 2023 this line item increased 546.38%. What does the City have to show for this astronomic increase to St. Paul taxpayers? What is the current budget amount for this line item?

As a property owner in St. Paul, I cannot carry the burden of the schools and city. The State and City increased taxes to procure a steady funding stream for roads and affordable housing. Where is the tax for education/schools?

I am looking forward to a new administration in St. Paul to hopefully have new eyes on the budget. Please read the article in the Star Tribune on Sunday November 23rd that has ideas on how to change funding streams to bring relief to homeowners. We desperately need new ideas, and we also need to get back to basics and not pet projects that cost us all but only benefit a few.
