Narrative 1

Synopsis :

On February 5th, 2025, squads responded to 1032 Minnehaha Ave on a report of an Alarm sounding. Upon arrival there were 6 people who were coming out of the house. The south door to the house had forced entry.

WILSON, KATHLEEN a 48-year-old female was arrested for a GM FTA warrant out of Pine County.

Narrative :

On February 5th, 2025, at approximately 1623 hours, I, Officer Baran, (squad 364) was dispatched to 1032 Minnehaha Ave E, on a report of an alarm sounding.

Upon arrival, the front of the house appeared to be secured. I went around the back and saw a group of people coming out of the house on the second floor.

Officer Adams (squad 371) remained with 4 of the people who came out of the house. I saw a white male turn around and head back inside of the residence. I heard him say, "I'm going back to get my stuff." I then saw a white female also head back into the residence. (very limited descriptions on the male and female) As I headed up the stairs I saw a knife on the steps on top of the fresh snow. As I approached the door, which was located on the south side of the house, I saw that the door had been forced open. I saw that the upper deadbolt had been damaged, I also saw that the door jamb had some fresh damage. I made announcements into the home that I was the Saint Paul Police and that they were under arrest. There was no response from inside of the house. I confirmed that the house was not on the vacant list. I requested a K9 officer, Officer Spear (squad 612) responded to the scene. Initially it appeared that this may have been a duplex.

Once K9 arrived on scene, we decided to clear the house without the dog. The house was not in fact a duplex. The people who ran inside had escaped out the front door, prior to other squads' arrival on scene. While clearing the house, I noticed the house was under remodel, there were appliances, and other remodeling equipment spread around the house. There was a cart with random personal belongings which appeared to belong to one of the people outside. Squads ran NCIC checks on all parties involved.

My arrestee, WILSON, Kathleen Theresa (DOB/19770116, 757 Bradley Street, No C/P) was placed under arrest for her GM warrant out of Pine County. WNO/58CR2010000

I read WILSON the Miranda warning while in the back of my squad.

Post Miranda WILSON stated that tonight, her and the people she had been with stated they were kicked out of 658 Wilson Ave. A male, identified verbally as GRAY, Matthew a 6'0 white male was the male who directed them to the address of 1032 Minnehaha Ave E. WILSON said GRAY kicked the door in, which had the damage.

I was not able to find a male with the last name of GRAY in DVS matching the description.

WILSON and her property were booked into the Ramsey County Jail without incident.

I took photos of the scene and uploaded via AXON.

A board up crew was called and completed.

I was able to contact a key holder, LEFEVRE, Kent- estimated damages are \$600.00

LEFEVRE will go to site tomorrow to get a better estimate of items missing and or damaged.

I gave LEFEVRE a CN.

Narrative :

On Wednesday, February 5th, 2025, at approximately 1630 hours, I, Officer J. Adams (Squad #371) responded to assist other officers on an alarm call at 1032 Minnehaha Avenue E.

When I arrived on scene, it was snowing. I noticed what appeared to be one set of fresh footprints at the front of the home. Other officers went to the rear of the address and I heard Squad #364 (Officer T. Baran) call out that he was with people in the back. I walked around to the back and saw two people near the base of the steps that go up to a door in the back. I heard Officer T. Baran tell one male to get his ID and then shortly after, Officer T. Baran noted there appeared to be forced entry with the door in the rear and he began walking up the steps.

I told the male to grab his ID and he told me he didn't have it with him. The male verbally identified himself to me as follows: "Zachary Joseph Mcurary". Officer T. Baran announced there was a knife at the top of the steps. The male I was speaking with had his hands in his pockets and due to the knife just being found, I wanted to ensure he did not have any weapons on him. I asked the male if he had weapons and he told me no. I felt a wallet in his pocket, which I removed, and it contained his ID inside with not the name he had told me. I asked him why he gave me a name different than the one one on his ID and he told me it was because he had a warrant. I also located a pocket knife in his jeans pocket that I held onto so he did not have access to it while I was interacting with him.

The male was identified by his photo ID as, "DALEY, Maxwell Patrick, DOB: 09/19/1997, address: 1385 Beech Street, C/P: #Unknown). I placed DALEY in handcuffs. I asked DALEY to take a seat

and shortly after he was complaining that his handcuffs were too tight because when he sat down one tightened on him. I had him stand up and I checked the handcuffs for proper fit. I adjusted one and double-locked them both. There was a female on scene that Squad #362 (Officer T. Lichtsinn) identified. I pat searched her for weapons and did not locate any. She was cooperative with officers. Another male appeared from the east side of the home and I asked him to walk over to me and he did. This male was identified as (HARRIS, Joseph Emmett McBride, DOB: 04/25/1979, address: 4547 34th Avenue S Minneapolis, MN 55406, C/P: #952-412-8087). I ran HARRIS on DATA and he did not have any warrants. HARRIS was very cooperative with officers and was released from the scene. The female who I mentioned above asked HARRIS to keep her two bags that she had with her and he agreed to do that for her.

I asked DATA to run DALEY and they confirmed he had a misdemeanor warrant for theft out of Ramsey County. I placed DALEY under arrest for lying to me about his name and for his warrant. I searched DALEY incident-to-arrest and located numerous pieces of tinfoil, baggies, and drug paraphernalia with drug residue on them. DALEY began complaining that he had not taken his seizure medication in approximately one week and wasn't feeling well. I asked if he wanted me to call paramedics for him and he said yes. I called Saint Paul Fire/EMS (SPFD) to the scene and they arrived to assess DALEY. DALEY was transported to Regions Hospital and I rode with in the ambulance while they transported him.

DALEY was assessed at Regions Hospital and released a short time later. I placed DALEY in the backseat of my squad car (#2072) and buckled his seatbelt.

At the LEC, I searched the items I removed from DALEY when I originally searched him. Inside a pill bottle that DALEY had was several pieces of burnt tinfoil, a random piece of jewelry, and six small baggies with a white powdery substance inside. I later weighed those white baggies at the LEC on the scale and their weight totaled 2.4 grams. I located a clear baggie with what appeared to be a blue pill that was cut in half. I located a piece of tinfoil with burn marks, residue, and possible drugs still inside. I located a piece of tinfoil with a clear baggie like the one in the pill bottle - this baggie was open and not secure. It had a fine, white, powdery substance inside of it. I located another piece of tinfoil with what appeared to have an unknown drug substance inside. I located a syringe with a small amount of a clear liquid substance inside. I seized five various pieces of drug paraphernalia with drug residue on each one. I located a receipt with a clear, crystal like substance inside. Each of these items were later turned into the SPPD HQ property room.

Squad #910 (Commander Kasal) was made aware of the arrest.

DALEY was booked him for his misdemeanor warrant out of Ramsey County (62SUCR242279), misdemeanor false information to law enforcement, and felony 5th degree possession of a controlled substance.

Narrative :

On 02/06/2025 at 0738 hours I, Officer Gallatin, conducted presumptive tests on items #1, #2, #3, #4, #5, #6 and #7 (Per SPPD presumptive Testing SOP). I was assisted by SPPD Narcotics Officer Daly for testing. Daly conducted presumptive testing as I recorded the results.

Item #1 consisted of 6 small baggies "tie-offs". 5 of the 6 were of the same size, color, and texture. One of those was tested (1A) and the remaining 4 were weighed together (1C). 1B was a single tie-off that was of a different consistency of the other 5. It was tested and weighed. The results were recorded below.

It should be noted that Officers tested and weighed the suspected C/S to get over the threshold of 5th degree felony charges for both Fentanyl and Cocaine. All of the suspected Methamphetamine was tested and weighed (GM level). There was clearly not enough C/S left of Fentanyl and/or Cocaine to reach any higher charges and the remaining small amounts of suspected C/S were not tested but rather weighed in there original and evidence packaging.
