The undersigned appellants, Rene and Kim Lerma, along with other aggrieved neighbors, hereby appeal the Planning Commission Resolution 17-64, dated October 20, 2017 in File Number 17-060-690.

1. The Planning Commission erred in, "affirming the Zoning Administrator's decision in part, by permitting the services proposed by Listening House as an accessory use to the church with 'revised' conditions that include meeting the standards and conditions for 'home occupation' as listed in Section 65.141 b, c, g and h of the Zoning Code." This error relates specifically to 65.141, Subd. (h), which requires that, "There shall be no detriments to the residential character of the neighborhood due to noise, odor, smoke dust, gas, heat, glare, vibration, electrical interference, traffic congestion, number of deliveries, hours of operation, or any other annoyance resulting from the home occupation." (Emphasis added.)

In its reiteration of the Zoning Code's clear standards and conditions for a "home occupation" to be applied to First Lutheran's offering of the Listening House services under 65.141, Subd. (h), the Planning Commission failed to adequately consider the established detriment to the residential character of the Dayton's Bluff Neighborhood closest to First Lutheran/Listening House. The code already required that Respondents have no such detrimental impact at the time of the Determination of Similar Use; and Listening House's presence in the neighborhood through the summer of 2017, had a dramatically detrimental impact on the residential character of the neighborhood. This information was well documented and before the Planning Commission at both the October 6 and October 20, 2017 hearings.

The nearly immediate impact of Listening House's presence included numerous incidents of Listening House guests defecating and urinating on private property owned by neighbors of First Lutheran, many incidents of extremely loud, often intoxicated, frequently belligerent, and sometimes psychotic guests of Listening House interacting with one another or the neighbors in ways that were unsafe, disrespectful, and sometimes criminal. The conduct was, generally speaking, beyond the pale of the other relatively slight nuisances contemplated by the code's reference to, "smoke dust, glare, business car, truck or small van traffic, odors, or electrical interference."

The "annoyances," that the Planning Commission failed to adequately consider when it merely reiterated the standards and conditions for "home occupation" pursuant to Section 65.141 b, c, g, and h of the Zoning Code, have become a responsibility for the neighbors of Dayton's Bluff to absorb, endure, document, intervene and problem solve in a manner that is

entirely unrealistic for people living, working, and raising families on nearby blocks. These nuisances, created by Listening House's use of the land rights they exercise under a ten year lease, have been carefully catalogued by the neighbors. Please see the attached log of neighborhood incidents that occurred throughout the summer of 2017.

The neighbors have borne the colossal effort of preventing even more egregious harm from befalling anyone of the many children (over a dozen) who live within a block of Listening House/First Lutheran, one of the many single mothers living in nearby homes, or over fifty-five year old residents who live in nearby multi-family dwellings, and to prevent further property theft or damage. The neighbors have worked tirelessly with law enforcement, mental health case managers, and Listening House Staff. They, in good faith, engaged mediation efforts with Listening House/First Lutheran. Despite all of this focused and coordinated energy, aimed at addressing the detrimental impact the Respondent has had on this neighborhood, their presence continues to cause harm. Listening House's presence reflects the reason a city code exists. Some businesses, non-profits, and services are compatible within residential neighborhoods; and some are not. Listening House's placement at First Lutheran is decidedly incompatible with the residential neighborhood in which it is located.

Moreover, Listening House's presence is not "low profile" as required by the revised conditions that the Planning Commission required of the nonprofit tenant in its October 20, 2017 Resolution. The attached log of nuisance behaviors, crimes, mental health emergencies and medical emergencies (often derived from drug and alcohol abuse) that the neighbors of Dayton's Bluff have had to address or absorb while meeting the life responsibilities that they have actually chosen, give some perspective on the issues.

2. The Planning Commission erred when it partially affirmed the Zoning Administrator's decision by permitting Listening House's services with revised conditions, including items 4 through 14, on pages three and four of the resolution. The revised conditions, look good on paper. However, the efficacy of these items to remediate the detriment to the residential neighborhood that Listening House has caused is speculative. If Listening House follows the conditions and they do not effectively eliminate the detrimental impact that the Respondent's presence in the residential neighborhood has caused, then the harms continue to befall the residents with no clear recourse for the neighbors, but to continue enduring the ongoing detrimental impact of Listening House's land use practices.

The neighbors engaged in conversation with the First Lutheran and Listening House staff in the final days before Listening House services began in Dayton's Bluff (early June 2017.) Despite the legitimate concerns clearly voiced by neighbors, Listening House did not pro-actively act to meet these needs, as they launched their services in June of 2017. For example, only in the final thirty days leading up to the October 20, 2017 hearing, did they, through our request at mediation, determine that they would review the cameras on a regular basis to look for their residents engaged in harmful conduct on the perimeter of First Lutheran's property. They

frequently answered our concerns by denying that their guests were the people causing the nuisances we documented. They repeatedly implored the neighbors to accept the reality that homelessness is a problem for all of us to face, address and solve, collectively.

No one in the neighborhood has abdicated their responsibility to do what is right in the face of a growing local, national and worldwide problem with homelessness. However, the weight and breadth of this problem does not require that we, the neighbors of Dayton's Bluff, forfeit our right to the quiet enjoyment of our homes.

Our neighborhood has long been among the top neighborhoods for placement of level three sex offenders in official and unofficial half way houses, in-patient and step down chemical dependency residential options, and other social services agencies. We are doing our part for disadvantaged and vulnerable populations. And, we are accustomed to living together as a truly diverse population.

Since having the problems caused by Respondent's presence foisted on us, our concerns have repeatedly been chided as inaccurate, uncharitable, lacking awareness of the scope and needs of the homeless, or naïve to what it would take to meet the problems Listening House guests are experiencing. The effect has been that as neighbors articulate the detrimental impact, they have been met with requirements that we prove which of their clients caused the specific problem at hand, and then ultimately, determine what Listening House should do about it. The responsibility to identify solutions to the irreconcilable differences between a low barrier day drop in center, with no requirements for sobriety, no controls for what guests do in the nearby neighborhood after spending time at Listening House, no screening for criminal or even serious criminal sexual backgrounds, have been left to the neighbors.

Meanwhile, the detrimental impact on the neighborhood has been clear. Attached is a chart from the St. Paul Police Department, collected on 463/464 Maria Avenue (the two properties that comprise the First Lutheran Campus). For the dates spanning June 1, 2017 –October 26, 2017 the two addresses have generated more than four times as many calls as they did in the same period in 2016 (prior to the opening of Listening House at First Lutheran.) This extraordinary 460% increase occurred when Listening House relocated to First Lutheran, despite an exceptional increase in additional "Proactive Police Visits" to these addresses.

Having to prove with air tight certainty which guest, at which point, engaged in which problematic behaviors with sufficient certainty to cajole the Respondents into effective intervention strategies is not the responsibility of the neighbors. In the face of this dramatic increase in the need for law enforcement intervention, the responsibility is on the Respondent to stop their detrimental impact on the neighborhood. It is unrealistic to expect any neighborhood, to consistently interface with such an immediate and significant uptick in nuisance behaviors.

Preventing this type of detrimental impact between such incompatible land uses is the public policy behind the code's existence. This dramatic increase in police activity, a 460% increase in traditional police responses to an address, in addition to an exceptional increase in Proactive

Police Visits, demonstrates that the neighborhood has been harmed by the Respondent's detrimental land use.

(Please see the attached charts on St. Paul Police Department calls to 463/464 Maria.)

The Planning Commission erred when it continued the Respondent's pattern of placing responsibility on the neighbors for addressing the problems Respondent caused. The record before the Planning Commission at the time it generated its October 20, 2017 resolution, included that through mediation, the neighbors came to Listening House/First Lutheran with every suggested solution to the detrimental impact their presence had on the neighbors. None of the solutions proposed came from the Respondent. And ultimately, within the context of the mediation process, Listening House/First Lutheran declined almost every single request of the neighbors. The only conditions to which they consented at all, were related to posting signs. The rest were only consented to, partially or qualified in a manner that left the neighbors little hope of Respondent's motivation to actually eliminate their detrimental impact on the neighborhood. Accordingly, it is an error for the Planning Commission to expect that Listening House/First Lutheran will hold themselves accountable to these well-intentioned 10/20/17 resolution requirements in a manner that will effectively remediate the detrimental impact their use of the property has had on the neighborhood.

3. The Planning Commission erred when some of its members voted on the weight of their consciences and not the requirements of the code. At the October 6, 2017 hearing, Kris Fredson explained that at the Zoning Committee he, "voted on his conscience." Not long after that declaration, Trevor Oliver mentioned that his religious upbringing was the influencing factor in how he would vote. Prior to these remarks, Commissioner Eckman asked if anyone knew where Listening House would move if the appeal were granted; while other concerns about renovation costs incurred by Listening House arose. These considerations shifted the focus from the code requirements to the concerns weighing on the consciences of the Planning Commission members. Neither the Chair, nor the other staff, nor the assistant city attorney challenged the drift from the competing tensions contemplated under to code to the personal ethics considerations they brought to bear on the decision making process.

Addressing the plight of the homeless certainly calls for extraordinary measures. However, governing bodies tasked with distributing the rights and restrictions of land use by the people they are sworn to serve, cannot exchange several residents' quiet enjoyments of their homes for Planning Committee members' quiet consciences.

As with the with Listening House and First Lutheran staff, none of the Planning Commission members who voted, live in the area negatively impacted by Listening House's land use. They have not been away at work to be contacted by a next door neighbor with the news that a psychotic man was sitting on a rocking chair on her porch in broad daylight. They have not been walking their children home to have an intoxicated man remove his penis from his pants in full view of the children and begin to urinate. They have not had their belongings stolen from their porches and out-buildings.

They have not stepped over piles of human excrement and hypodermic needles. They have not gone out for a run after a long day of work to have an extremely intoxicated man fall over and display seizure symptoms, then inexplicably dart up and walk a dozen or so feet until he collapsed again. If they have, such incidents have not happened on the same escalating frequency and scale as these neighbors have experienced through the summer of 2017. These are situations that residents are not, and should not be required to consistently manage as they go about their lives. The Planning Commission should have voted on the code; and at least some of their members clearly did not.

The Planning Commission failed to appropriately balance the property rights claimed by Listening House's lease from First Lutheran with the property rights of residents who are entitled to a place of quiet enjoyment in their homes. Throughout the summer of 2017, the residents of this neighborhood were repeatedly thrust into situations that, sometimes did and on many more occasions could easily have led to extremely dire consequences for themselves, their families, visiting friends and for the (increased) number of people ambulating the area in various states of chemically induced crisis, psychiatric decompensation or bare criminal conduct.

Indeed many people had their sense of safety and security negatively impacted by the behaviors that have spiked since Listening House arrived. The Planning Commission did not strike the appropriate balance between the civic responsibility of providing critical support for the most needy among us, and the equally critical need for families to have a place to let their guards down, to relax, replenish, and revive without spontaneously finding themselves in situations most are not equipped to handle. The code, seeks to deliver a better balance than the Planning Commission generated in its October 20, 2017 resolution.

4. The Planning Commission erred in its partial affirmation of the Determination of Similar Use based on the 2004 Planning Commission of similar use determination for St. Mary's Episcopal Church at 1895 Laurel Avenue (ZF# 04-175-573.) In that case, the approval allowed the church to lease space for "no more than ten persons" at a time to access a yoga studio, a home health care office, a non-profit travel organization, a massage therapist a psychologist, a piano teacher and a counselor. However, this is not similar use to that of Listening House's use of First Lutheran's facilities. As a low barrier day drop in center, many of the guests arrive in various states of intoxication, psychiatric decompensation, or extreme fatigue. Some combination of these factors often, culminates in criminal conduct or public nuisance activity, shortly before or shortly after spending time at Listening House. These land use characteristics are not similar to the attributes of the Episcopal Church's land use, whose guests would be seeking yoga, a non-profit travel organization, a piano teacher, or a massage therapist. As such, the use of the land is quite different; and the impact on the neighborhood has been substantially different.

The beauty of Listening House's offerings is that they, as they have remarked in various publications, "are not trying to fix anyone." On a fundamental humanitarian level, that is a remarkably generous and commendable offering. But it should not come at the expense

of the surrounding neighbors' rights to the quiet enjoyment of their own homes. Listening House's land use, specifically, the largely absent structure in the services it provides, is wildly different from the discreet, specific services provided at St. Mary's Episcopal. Accordingly, the Planning Commission erred in affirming the Determination of Similar Use.

(Urban Roots is a youth development organization that uses food and farming to transform the lives of young people and inspire, engage, and nourish the community.)

Urban Roots is also a tenant of First Lutheran Church along with Listening House. There are youth girls and boys on this property on a daily basis alongside Listening House guests.

On September 8th, 2017 a male Listening House guest walked up to a female staffer belonging to Urban Roots and exposed his penis to her. A police report was filed, please see the following police report for the Sex Offense - Lewd Conduct, Indecent Exposure.

Despite months of hearing from parents of minors along North Street that they are concerned about the safety of their children, Listening House chose not to inform the community members of the incident.

To Whom It May Concern:

As you are aware, the Listening House Day Homeless Shelter has now moved into our neighborhood - a residential neighborhood that also backs up to Swede Hollow Park. The move happened on June 5, 2017 and since then we are experiencing worsening negative behavior, not only for the home owners but for the local businesses in the near vicinity.

I don't know if you are aware of how Listening House and First Lutheran Church approached the residents of the neighborhood of their upcoming move into our neighborhood, They didn't! They chose not to notify anyone in the neighborhood, therefore suggesting this was a deliberate tactic so as to prevent any voice of opposition to their plan.

Listening House is a day homeless shelter, which means when the employees lock the doors at 4:15 p.m they go home. We residents have to call the police because of the following: people passed out on the ground, on benches, drinking, intoxication, stumbling down our streets, profanity, drug use, trash dumped everywhere, abandoned shopping carts, public urination and defecation. The clients of Listening House have no where to go after they close their doors at 4:15 p.m. so they stay in our neighborhood and set up camp in Swede Hollow Park and have set up tents on neighbor's private property, which has resulted in a major problem. We residents are having to clean up the trash that includes liquor bottles, cans, clothes, used toilet paper, sleeping bags, drug paraphernalia, hypodermic needle and other items left behind. We are constantly having to call the police and DSI.

My house is located at the dead end of North Street (beside Listening House & First Lutheran Church). Because of our safe location the neighborhood children choose to ride their bikes and play down here, but since LH has opened, fewer children are witnessed playing. Perhaps it has to do with finding a hypodermic needle in the LH parking lot.

We residents have been taking photos and documenting what we have had to encounter. I get multiple emails and texts almost daily from residents about incidents. One time my husband and I had to call 911 because five youths had parked in the LH parking lot and then walked across the street from LH to the front of our home and started rolling dice (gambling). They then started yelling & cursing so we called 911. The officers arrived quickly and when they pulled up, one male took of running through our front yard around to our backyard. When we saw officers in our backyard my husband went to talk with officers and was informed that they were looking for possible items disposed of by the youth in our backyard.

We are constantly dealing with people urinating in front of our homes, when you confront people to stop often times we are yelled out with profanity and to "mind our own business" and "what are you going to do about it".

We have witnessed cars pull up and park on North Street (in front of our home) and sleep overnight. LH gives out their WIFI password to guest, so they pull up and use LH WIFI and sleep in their cars overnight. In the morning when LH opens they go inside LH. My husband was in his car in front of our home and two homeless people asked him for a ride.

LH bases their services on people wanting help to better their lives and LH is providing this to those people. But the neighborhood has to bear the consequence of those who do not. Evidence of trash dumped on lawns, streets, parking lots, etc., finding human defecation on the sidewalk in front of your home, drug use and intoxication proves this. When we first found out that LH was moving here, my husband contacted LH and an employee admitted to him that they (LH) had their reservations about moving to a residential area but they did it anyway knowing what they were going to bring to our neighborhood.

My husband and I moved to our home 12 years ago. We knew this was a transitional area and within a short few years, we neighbors have revitalized this neighborhood! We got rid of two drug houses and the "slum lords". The homes in our neighborhood are majority owner occupied. The few rentals that we do have rent to people who also care and want to be a part of this neighborhood. Three homes on North Street alone have won the St. Paul Historic Preservation Award. With the help of the St. Paul Police Force, we accomplished all this to have a safe place for our neighborhood children to play and for us residents to have a safe place to live.

LH does offer help and a service to people in need but this type of establishment does not belong in a residential area. As the weeks go by this is becoming clear. The safety of residents and our quality of life has diminished significantly. Even if we wanted to put our home on the market, I really doubt we could find a buyer that would want to live next to this with people sleeping on the ground, on benches and stumbling down the street because they are intoxicated and all the trash. LH is destroying the neighborhood that we worked so hard to build.

There is a reason for Zoning. Zoning laws are created and meant to protect properties and to ensure that neighborhoods are not detrimentally effected by placement of entities (business) that should not be part of a residential zone. Listening House is a noble institution but that does not exempt them from Zoning laws and ordinances.

I have been keeping logs of all photos and incidents that we have experienced. I have attached logs one through nine.

Please consider the views and frustrations of residents who have worked so hard to revitalize and transform this neighborhood into an area where people want to live and raise their children.

Dear Mayor Coleman, Council Members, and Board Members:

I am writing to state my strong objection to the relocation of the Listening House to 464 Maria Street.

464 Maria is located in a very small neighborhood, five blocks long and at its widest spot, not quite three blocks wide. The area is crescent shaped. East 7th Street bounds the neighborhood along the south and cuts it off on the east. A bluff carved by the Mississippi River sweeps from 7th street on the west, curving north, and ects as a geological barrier. Because of the traffic volume, 7th Street acts to isolate the neighborhood from from the larger residential area across 7th Street to the south. In this small area, we already have five shelters / group homes.

While Swede Hollow, at the base of the bluff, has always attracted homeless people, Listening House has significantly increased the number of homeless, their activity level, and the quality of our lives. I live above the 100 plus steps down to Swede Hollow. I have owned my home since 2001, and lived here most of the time since 2003. The Hollow was one of the reasons I chose to purchase a home in this area. For years, during spring, summer, and fall, I walked my dog in the Hollow both in the early morning before work, and in late afternoon or evening. I now have two dogs, but, since the Listening House arrived, I will no longer walk in the hollow alone, even with the two dogs, because I do not feel safe. Whereas previously I might occasionally see one or two people who I guessed were homeless, I now regularly encounter groups of three or four. They congregate on the landing of the steps. They set up multiple camps visible from the walking paths. For the first time, this year, we see sleeping bags laid here and their on the hillsides of the Hollow.

My house also fronts the upper park. Similarly, I rarely to to the upper park anymore because on the men who take up residence on the benches and hang around at the periphery of the park near the old brewery. Thinning the buckthorn on the hillside across the street from my house seems to have discouraged the camping that was going on there.

The newly arrived homeless are much more aggressive than those from previous years. They careen through the Hollow on bicycles, in groups. They chase each other down the street in front of our house yelling. After a series of thuds and bangs, we sighted one running out of our fenced yerd. We suspect he was attempting to break in. This is a first for me, in my years of living here.

At our location, two blocks from the Listening House, and without children, our problems pale in comparison to those that our neighbors closer to the site describe. Still, we watch the daily procession down to the Hollow after Listening House closes and its executive director and staff retire to their homes in Crocus Hill, Merriam Park, Highland, and Woodbury. We deal with the increased population of people with no place to go and no gainful activity. We contend with their presence, their litter, their noise, the lack of restroom facilities and all that entails. This weekend, while trimming my bushes, I found two discarded tissues that had been used as toilet paper, another first during my years here. The arrival of the Listening House in our neighborhood has impacted our lives, and not in a good way.

I am surprised that in the capital city of a state whose governor is so concerned for equity that the city would allow this endeavor to move into a neighborhood that has been struggling for decades to reduce crime and become a good neighborhood for families. Isn't it time that the good Christians that the Listening House executive director and its staff claim to be made space in their communities, neighborhoods, and homes for some of the people for who they purport to care so much?

Zoning Appeal: Listening House 7.31.2017 Miranda Okonek 649 North Street

To Whom It May Concern:

My name is Miranda Okonek and have lived on North street for over 13 years, I rested a duplex at 653 North street was married in the backyard overlooking Swede Hollow Park and bought the house next door. Hive less than 50 feet from the doors of Listening House. My husband and I love raising our children in a diverse arban environment and are no strangers to crime and homelessness in Saint Paul. Since LH opened I have witnessed a huge uptick in crime and homelessness. Our bike and child carrier lock and all were recently stolen from our driveway. My daily walks in Swede Hollow Park are witness to more and more tents and encampments popping up right in my back yard, i've started to carry garbage bags with me on walks to pick up empty liquor bottles and trash because the city can't see everything when they drive by in their clean up trucks. Sadiy, the number of folks I've seen living in Swede Hollow has increased dramatically and now I have they City Parks and Rec on speed dial. After being confronted by a homeless fellow who was angry because he accused me of calling the cops on him, I no longer bring my 6-year-old daughter into the Hollow. I still walk daily in lower Swede Hollow Park with my dogs and report crime to the proper authorities at my own risk. I've watched and gotten to know many of the guests who frequent LH as folks who are living in the Hollow. Not all of them are scary. I feel bad for the ones who really want help. Unfortunately, most of the folks living in the park are exhibiting behavior that I do not deem suitable for my young child to bear witness. Screaming obscenities while in conversations on their LH provided cell phones, lude behavior, excrement, trash and public intuxication are seen on a daily basis. The LH tolks say they are providing metal health and chemical dependency services but I've seen intoxicated guests on their lawn on more than one occasion. My mom came by for a visit and was terrified by the folks she saw walking down my street after tH closed and begged me to move. I refused. In fact, I'm currently working on home improvement projects to increase the value of my home and neighborhood. I'm currently attending Metro State University, where I can walk to class and work on my BA. I love the diversity of my Historic neighborhood, and i love my neighbors. We have worked hard to make Dayton's Bluff a community where people want to move and raise their families. The addition of LH to our neighborhood is a harmful one. They attract a criminal element to our quiet dead-end street and the LH staff are providing the neighbors no accountability for increased crime and trash. In fact, they have never once answered their phone when I've called during business hours on several occasions to address the staff about crime and un savory guests. The similar use Zoning appeal is legitimate. The face of our neighborhood was changed when Listening House opened its doors. Listening House's services are too vague and the risk of harm from their clients to the neighbors is too great. The only similarity I can see between SI. Mary's Church and First Lutheran church are the fact that they are both churches located in Saint Paul. St. Mary's church is not incated near any green space or a public park, it is not on a dead-end street. I ask that you grant our appeal. Please keep our little neighborhood a safe place where we can live and raise our children in peace.

Homelessness is something that we have to deal with everywhere we go. The children ride their bikes at the dead end which is right next to L11. We encounter homelessness, at the upper and lower swede hollow. We walk to the library almost everyday, our path is right past LH. Also we encounter it at the library.

Inc other day as I walked with my children to the dead end to ride bikes, a homeless man that was walking to LH screamed at us angrily the whole way. When we go on our walks we find all sons of garbage, evidence of drinking. I have overheard homeless men discussing where they were going to go urinate. People loitering outside of LH before, during and after hours for 1.11. Trash piled up beside LH dumpster. Everywhere I go with my children there are homeless and evidence of

I'm very concerned with the affect of LH being in a residential neighborhood. I don't believe LH takes it seriously how much this affects our daily lives. We have to call the police every time something happens. Let alone not feeling safe everyday. Just in the first block of LH there are 15 children which is a big deal when they don't screen their clients, I have no idea who I am dealing with on the street which makes me feel unsafe. I shouldn't be afraid just to go on a walk with my children. I don't believe that a residential neighborhood is the best fit for what LH does.

To whom it may concern,

I, David Gustafson, the property owner of 629 North St. for the last eighteen years. Just found out a week ago, about the homeless day shelter located at the church across the street from my property. My tenants informed me of the situation before i received any notice in the mail, about a homeless shelter at the church. My tenants have witnessed people sleeping outside of the church property on the ground, as well as people arguing outside and asking them for money. My neighbors notified me of several thefts on the block in the past few weeks. Up until this point our neighborhood has been quiet and peaceful. My tenants no longer feel safe, and have resigned a one year lease two months ago. They and are now looking to terminate their lease because of the issues regarding the homeless shelter. I have been at the property the last 3 days doing maintenance and i have also witnessed these problems. As far as i know, there should have been a public hearing before a shelter like this is allowed to be placed in a neighborhood. What seems to be happening when the shelter closes, is that there is nowhere for these people to go so they are sleeping in the neighborhood and swede hollow park behind my property. This shelter placed at the church has caused many issues for my tenants and I. I hope you strongly consider relocating this shelter as i am about to lose my tenants, due to these issues.

We are having a harder time renting our apartments this summer. We have a standard for our tenants that helps support our responsible neighborhood and we do not want to lower our standard. With the observable behavior that has come along with the Listening House this is much harder to do.

The value of our investment is at risk. We are not a massive real estate company, just a couple who has their eggs in a small basket. Having a service provider move in and not take responsibility for the externalities of their services has major financial implications to our family."

Here are 4 emails that I sent out to various individuals about Listening House. They reflect my increasing frustration with the problems that Listening House has brought to our neighborhood.

June 1, 2017

Thank you to Chris and Brenda from First Lutheran and to Rosemarie and Axel for being at the neighborhood meeting last night. There was a great deal of tension and frustration expressed on both sides of the issue. The move of the Listening House programs to 8th and Maria took the neighbors by surprise. And, as you know, this neighborhood has gone through some very difficult times with well intentioned but poorly managed programs in the past. I hope we can resolve some of the expressed concerns so that the neighbors can provide a welcoming presence for the people whom Listening House will be serving. Last night's meeting was an essential first step to allow folks to talk about their fears. I am encouraged that we have a follow-up meeting on the calendar in two weeks so that we can work together to create an action plan for the future.

I have heard that we have been labelled NIMBYs by some. Last night I heard someone who knows nothing about our neighbors or neighborhood say that we lack compassion for the vulnerable and that he worries we will do harm to the people you serve. These kinds of attitudes about us are counterproductive, offensive, and will not give rise to the kind of cooperation that we wish to promote. As was pointed out at the meeting, we have 5 homes serving social service functions within the small wedge of neighborhood between First Lutheran and St. John's Lutheran on this side of 7th Street. No one is working to shut them down; they are not disruptive to our community. My hope is that the Listening House will become a positive force in our community. In order for that to happen Listening House needs to earn our trust by addressing the concerns of our community.

I am looking forward to working with you on a plan to keep our neighborhood both safe and welcoming.

July 7, 2017

It is 10:30; I just returned from my usual morning dog walk. In the upper park I encountered a woman with a back pack who was carrying a large can of beer or malt liquor. We greeted each other and she volunteered that she was there to "get away from the men for a while and have a drink." I believe that she, like the many individuals we have seen drinking in Swede Hollow Park, is a client of Listening House.

My husband and I walk our dogs around the neighborhood at least twice a day. We are in the habit of picking up trash along the way. This summer we have picked up more beer cans and liquor bottles than at any time in the past. And we also have picked up more clothing, food wrappers, napkins, rugs, and tarps than ever before. Our past in the

neighborhood extends back decades. Dave has lived here since 1979 and I have been here since 1992.

After the first meeting at Listening House I held out some hope that the organization would take responsibility for the problems it has brought to our neighborhood. I have lost that hope.

I was not able to attend the second meeting about Listening House last month. But reports about the meeting from my neighbors were disappointing. They tell me that rather than addressing the concerns of the neighbors we were once again told that we "lack compassion". One neighbor was told by a Listening House supporter that she has a "dark heart." I was very disappointed to hear that once again people who do not live in our neighborhood and who certainly did not seek to have this program placed in any of their own neighborhoods continue to insult those who express concern about the secretive way this program was dropped on us and who are interested in maintaining a safe and livable neighborhood for our families. Apparently the 2nd meeting did not advance the Listening House cause.

Like many others who live here, Dave and I like the living in a residential area with economic, ethnic, and racial diversity; we choose to live here. It appears that the neither the Listening House employees or First Lutheran staff choose to live with the problems they have brought to the neighborhood and show little interest in dealing with the concerns of the neighbors. Instead they show their "compassion" from 9 to 4:30 and then leave the problems they have brought to us behind as they head to more affluent neighborhoods and suburbs where they do not need to deal with homeless encampments just down the hill from their homes or with daily exposure to public drinking, foul language, and use of our neighborhood park to leave litter, clothing, and human waste. It is interesting to me that those who benefit by drawing a salary or rent from Listening House see themselves as "compassionate." It seems they expect the neighborhood residents to constantly monitor our streets and parks for illegal activities after they and their compassion retreat to their safe, clean neighborhoods.

I have come to the conclusion that Listening House is a program that should not be located in a residential neighborhood. Until it moves to a more appropriate place, the staff should show some willingness to clean up the messes their clients leave behind and to assure after-hour security for our streets and park.

July 12, 2017

Like my neighbors, I am discouraged by the secret way the move was made from downtown to our neighborhood. But the real problem is the the huge increase in the number of homeless individuals who are living in Swede Hollow. Today, I visited an area that Dave and I cleared out just last week. No tent this time, just lots of beer cans, bottles, clothing, food wrappers, plastic bags, cardboard, and used toilet paper...Yuk! Today, there was another fight on the church patio in front of Listening House. The presence of Listening House in our residential neighborhood has significantly reduced our quality of life. I used to enjoy taking walks in Swede Hollow Park. Some of my

neighbors no longer walk down into the Hollow because of the trash (a snowblower...really? in July? grocery carts, and the usual bottles, cans and clothing and because of the many homeless who are living there... one neighbor said it is just "scary" down there. A business, even a well intentioned non-profit business should not be able to destroy the peace and security of the residents who have lived here long before that business arrived and who hope to live here long after Listening House departs.

July 24, 2017

Today there is a person sleeping under a blanket on a bench outside of Listening House. It is 11:30 a.m. and he has been there since before 7:00 this morning. We called the police and an officer responded, but because the church is private property and LH staff are fine with people living outside their doors, the officer told us that there is nothing he can do. Do we need to put up with people living in our residential neighborhood streets and parks? During the LH day, these folks can use the sanitary facilities in Listening House (except for weekends, Wednesday and Friday afternoons, before 9:00 am and after 4:00 pm, or over the noon hour, of course). But for most of the day the homeless who increasingly are coming to live in our neighborhood just head for the woods behind our homes.

I understand that the Burger King on 7th has stopped leaving condiments, including cream for coffee, on the counter and that the Holiday station down the street is considering closing at 10:00 pm because of problems with an influx of homeless individuals in the evenings. The number of beer cans and other alcohol containers that my husband and I pick up on our daily walks with our dogs in Hamm and Swede Hollow Parks has increased since LH came to our neighborhood. None of the LH or First Lutheran Church staff live in our neighborhood and they seem uninterested in the disruption they have caused. No one remains after 4:30 except those of us who live here and the homeless. Of course, the level of trust between the neighbors and LH and First Lutheran is low, because from our perspective they intentionally did not inform or meet with the neighbors before the move of the day shelter for the homeless to our neighborhood was settled and a 10 year lease for 464 Maria was signed. What can we do, and what will the City of Saint Paul do to deal with the homeless problem in our neighborhood and city?

Good Afternoon to Mr. Chair and members of the Zoning Committee.

My name is Kristenza Nelson. I am a working single mother who resides with my two sons at 653 North Street, just up the road from Listening House. Alex is 12 and Andreas is 13. I have stayed in our home on North Street because of the strong community and sincere support I found in my neighbors. We have lived in our home for 18 years.

I have three concerns in line with community values I wish to bring before this committee.

The comprehensive plan housing strategy H3-4 is not consistent with the plan's land use policies. Listening House at 464 Maria and First Lutheran are located along side a RT1 zone and are not compatible with the homes and families in the residential neighborhood.

The first concern I share is in regards to the safety for the dozens of children living in the neighborhood and the young people working with Urban Roots, which is a nonprofit that provides neighborhood youth with employment opportunities through organic gardening. They are housed in First Lutheran church.

I have witnessed leering by LH clients towards young woman as they arrive to start their work day.

As a single mother my main concern is for the safety of my children. As an educator my main concern is for the safety of all children. LH does not screen their clients for criminal backgrounds or warrants. The program is open to the homeless population regardless of prior convictions, including sex offenders, persons

just released from prison, clients with current alcohol and drug abuse issues and those struggling with mental health problems.

I am an environmental education teacher at a nature center. It is actually my job to take children outside daily. I now live on a street where it is unsafe for my own children to be outside. At a time in their lives where they should be experiencing more independence I am more uncertain of their surroundings. Since LH has opened its doors I now live on a street where being outside is being witness to assaults, both verbal and sometimes physical, , public urination, intoxication, manic behaviors vagrancy, and litter including tossed hypodermic needles.

Since LH opened its doors on June 5th there have been 39 logged 911 calls to 464 Maria. Note, this does not include calls made to the east district office or non emergency. Prior to LH opening there were zero calls to 464 Maria St. DSI has come out to remove camps 12 times since LH has opened. They have made 8 referrals to Park and Rec to clean up excessive trash. This clearly illustrates a safety problem and an increased pattern of disturbance to the surrounding community. In my 18 years living here I have never seen tents in the Hollow until LH moved into our neighborhood.

My second concern refers to accountability. The employees of LH are not able to provide adequate services to the clients invited into the neighborhood. They are not in a position to monitor surrounding green space and are in fact contributing to a growing population of camps in Swede Hollow Park. I have personally witnessed LH clients in camps in Swede Hollow Park after employees have left LH for the day. These camps are growing in size, in our backyard, as I put my children to sleep at night.

When staff leave no one is available to support clients in crisis. Neighborhood residents are left to fill that void. As LH staff have suggested, we call the police. This approach is not always successful. The SPPD does not have the resources to address the

on going and increasing volume of issues of homelessness that LH is embedding within our neighborhood.

My third concern is that of transparency. There has never been transparency between LH or FL towards the residents of the neighborhood. We were never notified of the change in programing at FL. LH is not transparent with residents about the clients they serve or actual services provided. We are not seeing the success stories. I am sure there are some. Homelessness is clearly a huge problem and people deserve help and intervention, however this programing is not compatible within a residential neighborhood. What I am seeing is the promotion of homeless culture in a RT1 zone.

The three young girls walking down the street did not need to see a LH client changing shorts behind a tree.

My son Alex was dropped off at home by a friends mother. She witnessed an altercation in FL parking lot and was visibly shaken. The next day they cancelled plans to come to our home. She didn't feel that this was a safe neighborhood.

My son Andreas is on the track team. I will no longer allow him to run through SHP. Children should be allowed to run in our neighborhoods.


All children have the right to be outside, to be safe in our neighborhood streets and parks.

The use of LH as an accessory is inconsistent with the comprehensive plan as stated in Section 4a and 4d. It has proven to not only be incompatible with adjacent properties but detrimental to the youngest members of our neighborhood.

For the safety and well being of our children and families I ask you to grant the appeal.
