SUMMARY OF ENGINEERING RECOMMENDATION Energy Park Drive New Sidewalk Construction

Ward 4

PROJECT:

This project is to complete the city sidewalk on the north side of **Energy Park Drive** between **Transit Way and Raymond Avenue.** The new sidewalk is approximately 620' long and will be constructed in front of one commercial property. This sidewalk construction is to be done in the 2015 construction season.

EXISTING CONDITIONS:

There is no sidewalk on the north side of Energy Park Drive in this area. The area where the sidewalk is to be constructed is basically flat with some boulevard trees.

INITIATING ACTION:

This order was initiated by District 12 sending a letter requesting this walk to be completed.

ALTERNATES:

Do nothing and this area will stay an incomplete walk where pedestrians will need to use the street.

POSITIVE BENFITS:

The people who live in the area will have greater walking access to the abutting stores. This improvement will positively affect many.

ADVERSE EFFECTS

Normal problems associated with construction such as noise, dust, and general disruption to the neighborhood. There are direct assessments to the abutting properties and some of them may contest the project.

EFFECTS ON TREES:

There may be a need to remove some boulevard trees for the new walk but the walk may be able to meander around trees to lessen the impact.

TIME SCHEDULE:

To be done during the 2015 construction season.

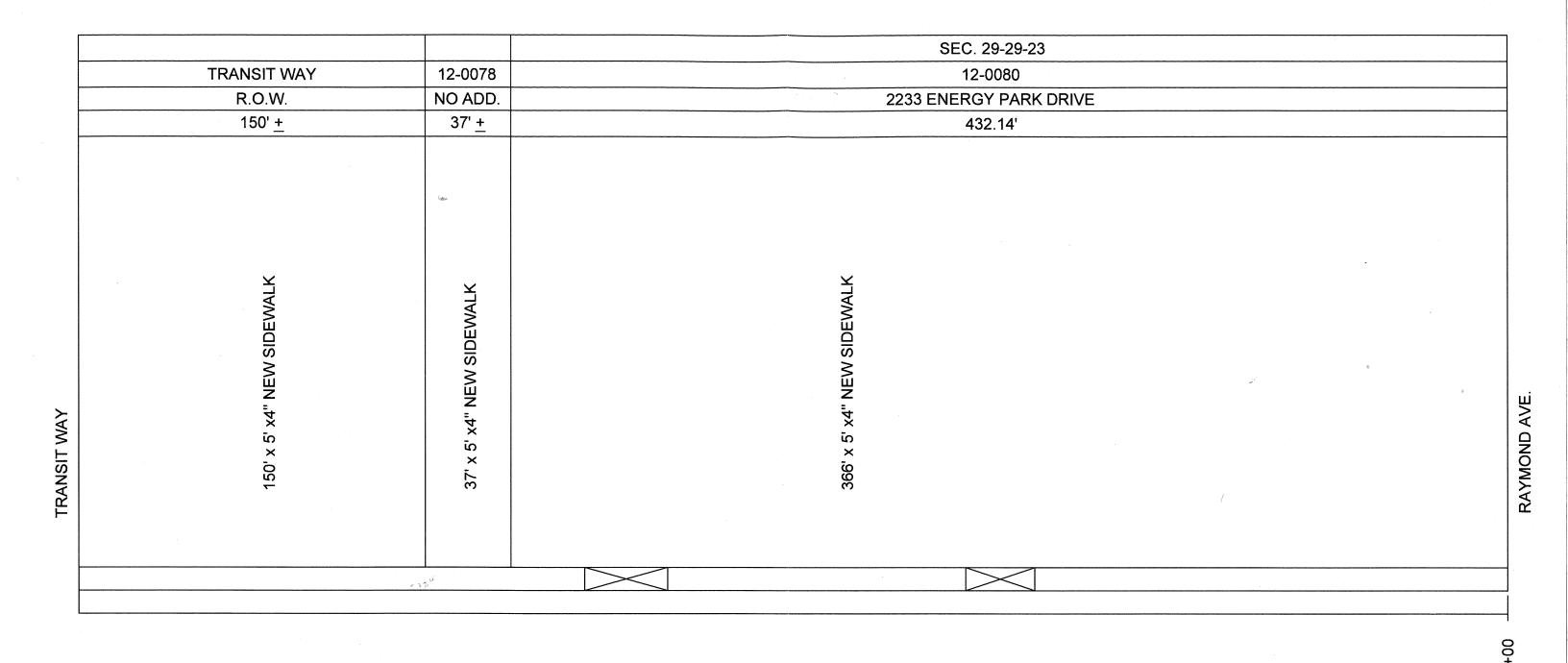
