To Whom It May Concern:

Below is a letter sent to all Saint Paul City Councilmembers last Friday, November 1st, 2024:

Dear Councilmembers,

Thank you for the work you do to support all residents of Saint Paul.

We write, today, to summarize neighborhood concerns about the proposed rezoning and building of a supportive housing facility at 470 White Bear Avenue. These concerns include:

- Inadequate on-site or nearby legal parking for residents, staff, supportive staff, and guests, thus creating hazardous neighborhood conditions at this busy intersection
- What we deem as illegal spot-zoning of this 470 White Bear Avenue property and concern for continuing city activity of this nature, thus diminishing the values of our single family residences and properties
- The City of Saint Paul and developers encouraging violations of State of Minnesota "drug-free zones" by housing known drug users among families with children and within the State's established boundaries of two elementary schools

Thank you for opposing, with us, this rezoning and building.

Might a better location for the above referenced housing facility be adjacent to SunRay Library at 2105 Wilson Avenue, Saint Paul? This location is near bus transit hubs and within walking distance of SunRay Shopping Center with groceries and clothing, employment, and many other amenities. This would also avoid negatively impacting our established residential neighborhood that contributes to Saint Paul's tax base. The Church of Saint Pascal Baylon's property would be open to single family lots, consistent with our immediate neighborhood.
