Whereas, There was heretofore presented to the Council of the City of St. Paul, the petition of Geo. Benz & Sons, a corporation, and others, being the owners of all the property along the line of the alleys hereinafter described, praying for the vacation of the alleys in Blocks 1, 2, 3, 4, 5, 6, 7 and 8, of Harvester Heights Addition to the City of St. Paul, as shown upon the blue-print attached to said petition, which said petition is duly verified as required by law and sets forth the facts and reasons for such vacation; and

Whereas, The Council of said City deemed it expedient that the matter therein referred to should be proceeded with, and ordered said petition and accompanying plat to be filed of record in the office of the City Clerk, and ordered said Clerk to give notice by publication in the official paper of said City in the manner and for the time required by law, that said petition and the subject matter thereof would be heard and considered by the Council at a meeting thereof to be held in the Court House on the 22nd day of August, 1922, at ten o'clock A.M., which said notice was duly published, and given; now therefore, it is hereby

Resolved, By the Council of the City of St.Paul, that the above described
alleys, as shown upon said blue-print, be and the same are hereby vacated and discontinued
as public alleys, subject expressly to the following conditions and reservations, viz:

(1) All the conditions, reservations and provisions contained in Ordinance
No.3394, entitled "An ordinance regulating the procedure and prescribing the conditions
for the vacation of public grounds, streets, alleys and highways in the City of St.Paul,"
approved March 16th, 1915.

(2) The bond provided for in said ordinance to be filed by said petitioners
is hereby fixed at the sum of One Thousand Dollars (\$1000.00).

(3) The said petitioners shall pay into the treasury of the City of St.Paul,
the sum of One Hundred Eighty Dollars (\$180.00) together with the costs of this vacation
proceeding.
